MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$56,543,765, which includes an estimated construction cost of \$44,372,576 (\$308/sf). The basis of the estimated maximum Total Facilities Grant would be \$49,717,714, which excludes: legal fees, portions of the auditorium renovation cost and associated OPM and designer fees, costs associated with abatement of asbestos-containing floor materials, site costs in excess of 8% of total building cost, Alternate No. 1 for a storage shed, costs associated with mailing and moving, owner's and construction contingency costs, and FF&E costs above \$2,400/student.

MSBA staff recommends an estimated maximum Total Facilities Grant of \$34,926,694; however, the District may be eligible for up to an additional \$2,248,000 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a maximum Total Facilities Grant of \$37,174,694 for the Project Scope and Budget Agreement and Project Funding Agreement for an addition and renovation project at the Ayer Shirley Regional High School.
