Discussion

The OPM and Designer conducted a feasibility analysis of the facilities and developed a schematic design including a proposed scope of work, schedule, and estimated budget. The District's Designer, Kaestle Boos Associates, Inc., recommends removing the original windows at the Breed Middle School and replacing them with a combination of aluminum glazed storefront units, curtain wall systems, and translucent insulated wall panels. The Designer also recommends completely removing the ethylene propylene diene monomer ("EPDM") membrane roof at the Lynn Vocational Technical Institute down to the roof decking and replacing it with a new EPDM roof system. The Designer has confirmed that the windows and roof will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analysis and proposed schedule provided by the District and discussed the scope and budget with the District and its consultants. The District provided a Total Project Budget of \$2,186,698 for the Breed Middle School, which includes a construction cost of \$1,796,674. Construction costs at the Breed Middle School include:

- \$93.52/sf for aluminum glazed storefront windows; \$118.93/sf for curtain wall systems; \$52.62/sf for translucent insulated wall panels; and, associated costs of \$220,684 for demolition, abatement, floor tile replacement, and metal panel infills.

The District is also proposing four add alternates:

- \$55,000 for replacement of overhead roller doors;
- \$166,000 for replacement of exterior doors;
- \$85,000 for an upgrade to translucent glazing; and
- \$117,000 for interior roller shades.

The alternates will only be considered eligible expenses if they can be accommodated within the Total Project Budget and within the estimated maximum Total Facilities Grant.

The District provided a Total Project Budget of \$4,817,087 for the Lynn Vocational Technical Institute, which includes a construction cost of \$4,173,000. Construction costs at the Lynn Vocational Technical Institute include:

- \$12.59/sf for EPDM roof replacement and \$1,635,114 for roof deck repair, drainage repair, metal wall panels, and above-the-roof-line repair of masonry and thru-flashing.

The District is also proposing three add alternates:

- \$201,038 for a 30-year warranty for the EPDM roof;
- \$251,297 for a polyvinyl chloride ("PVC") roof in lieu of the EPDM roof; and
- \$150,778 for a 30-year warranty for the PVC roof.

The second alternate will only be considered an eligible expense if it can be accommodated within the Total Project Budget and within the estimated maximum Total Facilities Grant. The first and third alternates are ineligible for reimbursement, and the District will consider these alternates only if they can be accommodated within the Total Project Budget.

MSBA staff recommends an estimated maximum Total Facilities Grant of \$1,671,304 for the window replacement project at the Breed Middle School and \$3,525,417 for the roof replacement project at the Lynn Vocational Technical Institute, for a total estimate Total Facilities Grant of \$5,196,721; however, the District may be eligible for up to an additional \$89,338 in grant funds for the Breed Middle School and \$202,667 for the Lynn Vocational Technical Institute, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a maximum Total Facilities Grant of \$5,430,324 for the Project Funding Agreement for the window replacement project at the Breed Middle School and for the roof replacement project at the Lynn Vocational Technical Institute.
