MSBA staff has reviewed the Feasibility Study and accepts the District's preferred solution.

Discussion

The existing Briscoe Middle School is a 144,349 square foot building located on an eight acre site, that currently serves grades 6-8 with a current enrollment of 933. The Briscoe Middle School, built in 1923 as a high school, has operated as a middle school since 1965 with most of the original infrastructure and features still in place. The building has not undergone significant upgrades aside from routine maintenance of the brick masonry exterior, repair of masonry lintels and sills, replacement of single pane windows with inoperable double pane windows in 1995, a roof replacement in 1993, and boiler replacement in 1955. The District's Statement of Interest ("SOI") identified numerous deficiencies in the existing middle school including undersized classrooms, overcrowding, deficient handicap accessibility, lack of insulation and ventilation, aged building systems, insufficient parking, and limited outdoor space.

As part of the Feasibility Study, the District performed an assessment and evaluation of the Memorial building and its site as a potential solution to the deficiencies identified in the SOI. The Memorial Building is a 103,000 square foot building built in 1954 with no additions or major renovations to date. The Memorial Building served as a school until 2005 when grades 6-8 were consolidated at the Briscoe Middle School. The Feasibility Study identified numerous deficiencies in the Memorial Building including undersized classrooms, deficient handicap accessibility, lack of project and planning space, outdated building systems and an inefficient building envelope.

In conjunction with its consultants, the District performed a comprehensive assessment of the existing conditions and the educational program and received input from educators, administrators, and facilities personnel. The District also performed an assessment and evaluation of a possible grade reconfiguration based on the District's desire to pursue a grade 5-8 middle school educational model. On February 26, 2014, the School Committee unanimously voted to approve pursuing a middle school Grade 5-8 configuration as part of the Feasibility Study. Based on the findings of this effort, the District and its consultants initially studied eight preliminary options that included four addition/renovation configurations and four new construction options. The following is a detailed list of the preliminary alternatives considered.

3	Construct a new 5-8 middle school on the existing Briscoe Middle School site
4	Renovate and expand the Briscoe Middle School for use as a 5-8 middle school
5	Construct a new 6-8 middle school on the Memorial Building site
6	Renovate and expand the existing Memorial Building for use as a 6-8 middle school
7	Construct a new 6-8 middle school on the existing Briscoe Middle School site
8	Renovate and expand the Briscoe Middle School for use as a 6-8 middle school

The District investigated and found the Briscoe Elementary School site with its limited area to be insufficient for a facility that would conform to MSBA guidelines. This finding eliminated the options proposed for the Briscoe Middle School site, options 3,4, 7, and 8. The District found that the Preliminary Design Program reinforced prior grade configuration analysis, and determined that in line with the District's stated goal to pursue a grade 5-8 middle school, it would not pursue "Option 5" and "Option 6." The District advanced the remaining two options for further development and consideration in the final evaluation and included an additional "Option 2B" - a second renovation and addition option which considers re-using less of the existing Memorial Building.

In order for the District and the MSBA to understand the financial impact of including an auditorium that is to be ineligible for reimbursement in the proposed Middle School Project, the MSBA requested the District include at least one alternative that does not include an auditorium in the final evaluation of alternatives (Option 1B below).

MSBA staff and the District agreed to four final options for further development and consideration in the final evaluation and development. Preliminary design pricing for these options is presented below.

The District has selected "Option 1A" – which replaces the existing Briscoe Middle School with a new 5-8 middle school on the Memorial Building site, as the preferred solution to proceed into Schematic Design. This option represents the District's solution to deliver its desired educational program for a four-grade middle school. The proposed solution will arrange team spaces in the District's ideal configuration to allow for collaboration between teachers and students to facilitate project-based learning. After reviewing the costs associated with the auditorium, the District indicated that the auditorium is a vital educational and community resource which cannot be eliminated from the proposed middle school program, and therefore eliminated "Option 1B." In addition, and based on evaluation of the existing conditions, renovation of the existing building will require full compliance with the building code for new construction resulting in the renovation/addition options, "Options 2A and 2B" having higher estimated construction costs. Additionally, it was determined that "Option 1A" could best satisfy the District's goals of educational visioning and program, where the addition/renovation options would compromise important relationships between the various educational program elements by constraining programs to areas of the existing building footprint.

The District presented its proposed project to the MSBA Facilities Assessment Subcommittee ("FAS") on February 25, 2015. At that meeting, members of the FAS discussed the proposed academic neighborhoods, professional development of faculty, afterschool programming, ineligible costs, and design considerations relating to classrooms, science labs, courtyard maintenance, handicap accessibility, security and building envelope.

MSBA staff reviewed the conclusions of the Feasibility Study, all subsequent submittals, and the enrollment data with the District and found:

- 1) The MSBA has reviewed the Feasibility Study and subsequent material and finds that the options investigated were sufficiently comprehensive in scope, the approach undertaken in this study was appropriate, and the District's preferred solution is reasonable and cost-effective and meets the needs identified by the District.
- 2) The District has submitted an operational budget for educational objectives and a capital budget statement for MSBA review.
- 3) The District's schematic design submittal will be subject to final review and approval by the Department of Elementary and Secondary Education as part of the schematic design submittal prior to a Project Scope and Budget Agreement.
- 4) Subject to Board approval, the MSBA will participate in a project that includes spaces that meet MSBA guidelines, with the exception of variations previously agreed to by the MSBA. All proposed spaces will be reviewed during the schematic design phase.
- 5) As part of the Schematic Design phase, the MSBA will continue to work with the District to understand the scope of work and associated square footage in order to determine a mutually agreeable methodology to differentiate between eligible and ineligible costs. Work associated with the proposed auditorium and dental clinic will be ineligible for reimbursement.

Based on the review outlined above, staff recommends that the City of Beverly be approved to proceed into Schematic Design to replace the existing Briscoe Middle School and the Memorial Building (served as a middle school until 2005), with a new 5-8 facility on the site of the existing Memorial Building.
