Discussion

The District was originally invited to collaborate on a Feasibility Study with the MSBA in November of 2009. The MSBA Board of Directors subsequently approved the City's request to include studying the feasibility of a combined JQUS and Boston Arts Academy ("BAA") and, on October 2, 2013, the MSBA Board of Directors approved the City of Boston's preferred solution to replace the existing JQUS and the BAA with a new facility located on Parcel 25.

As the costs of adapting the site for a combined school facility became more defined, the City was not clear as to whether the use of Parcel 25 was the most appropriate and cost-effective solution for the City. The MSBA and the City discussed these issues and mutually agreed that it was prudent to pause with the proposed Parcel 25 solution so the City could identify and consider alternative sites for the JQUS and BAA.

Pursuant to conversations between the MSBA and the City of Boston, the City requested to separate the two potential projects from a co-located school to individual projects in the MSBA's capital pipeline. On November 19, 2014, the Board of Directors voted to rescind its October 2, 2013 vote to accept the City of Boston's preferred solution to replace the existing JQUS and the BAA with a new facility located on a new site.

On November 19, 2014, the Board of Directors also invited the City of Boston to continue to collaborate with the MSBA to conduct a second Feasibility Study and Schematic Design for a potential project for the JQUS. The invitation to collaborate with the MSBA to conduct a second Feasibility Study is subject to certain conditions that are set forth in the Board vote and accompanying memo, including the study being based on the previously agreed upon enrollment of no more than 650 students in grades 6-12 and subject to the City being solely responsible for the costs of this second study.

The City has now requested that the MSBA extend the term of the Feasibility Study Agreement, as amended. MSBA staff reviewed the City's request for an extension, and recommends continuation of collaboration between the City of Boston and the MSBA, in accordance with the following:

- 1) The City and its consultants complete and submit an updated Preliminary Design Program to the MSBA by October 1, 2015.
- 2) The City and its consultants complete and submit an updated Preferred Schematic Report in February 2016 for consideration by the MSBA Board of Directors at its scheduled March 2016 Board meeting.
- 3) The City and its consultants complete and submit a Schematic Design Submittal to the MSBA in August 2016 for consideration by the MSBA Board of Directors at its scheduled September 2016 Board meeting.
- 4) The City has stated its commitment to completing the study within the period defined above.

Based on the review outlined above, staff recommends that the Executive Director be authorized to extend the term of the Feasibility Study Agreement between the MSBA and the City of Boston, as part of its Invitation to Feasibility Study for the Josiah Quincy Upper School by five additional months, from June 30, 2016 to November 30, 2016, in order for the District to complete the phases of the grant program through Project Scope and Budget.
