Introduction:

The Massachusetts School Building Authority (the "MSBA") initially developed the Model School Program (the "Program") in 2008 to effectively adapt and re-use the design of successful, recently constructed high schools, and has since expanded the Program to include elementary schools, middle schools, and schools with other grade configurations. From August 2008 to June 2011, the MSBA Board approved a total of 16 Model Schools for the Program. These schools were considered to have exemplary designs that best met the needs of the Program at the time. However, because the majority of these schools were designed using building code design standards that are now outdated, they are no longer aligned with the goals of the Model School Program.

Since its inception, the MSBA has periodically updated the list of pre-qualified model schools and anticipates continuing this practice to ensure that available model school designs remain relevant and adaptable to current building codes and district needs. More recently, the MSBA issued a Request for Qualifications in December 2015, resulting in 20 applications and 12 new Model Schools approved by the MSBA Board of Directors on July 20, 2016. That solicitation included minimum "threshold" requirements including the following:

- The proposed Model School must be all new, PK-12 construction, located within a 125 mile radius of Worcester, MA;
- The proposed Model School must have been permitted using the 780 CMR Massachusetts State Building Code 8th edition or the 7th edition or, if not permitted in Massachusetts, any building code or design criteria using the International Energy Efficiency Code ("IECC") no earlier than the 2006 edition, and ASHRAE 90.1 no earlier than the 2004 version;
- The proposed Model School must have been registered with either USGBC "LEED-S" or Collaborative for High Performance Schools ("CHPS"), and;
- The proposed Model School must have been open for full occupancy for a minimum of 12 months as of March 1, 2016 (using the substantial completion date as the starting date of occupancy; for phased occupancies, using the final substantial completion date).

The following list of the original 16 Model Schools shows that, with the exception of the Lincoln Elementary School in New Bedford, none of the original Model Schools meet the minimum State Building Code requirements noted above, and no longer meet the standard of "recently constructed" as required in the original 2008 Program.

*The 7th edition Massachusetts State Building Code became mandatory for permit in March 2009. **The City of Westfield selected the Williamstown model school for the replacement of the Abner Gibbs Elementary School. However, construction on the Abner Gibbs project stopped in December of 2012 due to a preliminary injunction based upon project site status as Article 97 "Protected Land". Although removed from future use, this model or another may be grandfathered for use by the City of Westfield if they are able to proceed under the current Project Funding Agreement for the Abner Gibbs Elementary School project.

***This school design was submitted for consideration in the MSBA's 2015/2016 Model School procurement process and was again approved for use in the Model School Program by the MSBA Board on July 20, 2016.

Recommendation:

MSBA staff recommends that the schools listed above are removed for use in the Model School Program for the following reasons:

- The MSBA Board has approved 12 new Model Schools that better meet current building codes and MSBA standards; and
- The original Model Schools, with the exception of the Lincoln Elementary School in New Bedford, do not meet the minimum threshold requirements described in the 2015 solicitation for Model Schools.¹

This recommendation will be effective January 1, 2017.

¹ The Lincoln Elementary School in New Bedford was resubmitted and reviewed as part of the submittals received for the 2015/2016 procurement for new Model School designs and was approved for use in the new Model School Program by the MSBA Board on July 20, 2016, and will remain in the Program.
