Discussion

The OPM and Designer conducted a feasibility analysis of the facilities and developed schematic designs for the projects, including a proposed scope of work, schedule, and estimated budget. The District's Designer, Tai Soo Kim Partners, LLC, recommends a boiler replacement project at the Fletcher Maynard Academy and a roof replacement project at the Kennedy-Longfellow School. The Designer has confirmed that the boiler and roof will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analysis and proposed schedules provided by the District and have discussed the scopes and budgets with the District and its consultants.

At the Fletcher Maynard Academy, the District has provided a Total Project Budget of \$904,457, which includes a construction cost of \$600,661. Construction costs at the Fletcher Maynard Academy include:

- \$194,351 for the installation of three boilers
- \$406,310 for demolition and other associated boiler work

At the Kennedy-Longfellow School, the District has provided a Total Project Budget of \$3,264,968, which includes a construction cost of \$2,804,463. Construction costs at the Kennedy-Longfellow School include:

- \$1,698,744 (\$30.62/sq. ft.) for the thermoplastic polyolefin ("TPO") roof
- \$217,024 for TPO exterior wall covering of existing penthouse
- \$888,695 for hazardous material abatement, demolition, and other associated roof work

MSBA staff recommends a combined Estimated Maximum Total Facilities Grant of \$1,854,103; however, the District may be eligible for up to an additional \$88,078 in grant funds, subject to the MSBA's review and audit of the owner's and construction contingency expenditures. Accordingly, MSBA staff recommends a combined Maximum Total Facilities Grant of \$1,942,181 for a boiler replacement project at the Fletcher Maynard Academy and a roof replacement project at the Kennedy-Longfellow School.
