Recommendation

That the Executive Director be authorized to enter into a Project Funding Agreement with the City of Boston for: (1) a window/door replacement project at the Charles Sumner Elementary School; (2) a window/door replacement project at the Curley K-8 School; (3) a window/door replacement project at the David A. Ellis Elementary School; (4) a partial window/door replacement project at the Donald McKay K-8 School; (5) a window/door replacement project at Dorchester Academy; (6) a window/door replacement project at the Grover Cleveland Middle School; and (7) a window/door replacement project at the Young Achievers Science and Math Pilot K-8 School.

The City of Boston has requested an additional 30 days beyond the requisite 90 days to obtain local funding for these projects. Consequently, staff is recommending that the District be allowed an additional 30 days, for a total of up to 120 days, to secure local funding for these projects.

Discussion

The OPM and Designer conducted a feasibility analysis of the facilities and developed a schematic design including proposed scopes of work, schedules, and estimated budgets. The District's Designer, Dietz & Company Architects, Inc., recommends: (1) a window/door replacement project at the Charles Sumner Elementary School; (2) a window/door replacement project at the Curley K-8 School; (3) a window/door replacement project at the David A. Ellis Elementary School; (4) a partial window/door replacement project at the Donald McKay K-8 School; (5.) a window/door replacement project at Dorchester Academy; (6) a window/door replacement project at the Grover Cleveland Middle School; and (7) a window/door replacement project at the Young Achievers Science and Math Pilot K-8 School. The Designer has confirmed that the windows and doors will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analysis and proposed schedules provided by the District and have discussed the scopes and budgets with the District and its consultants.

- 1) At the Charles Sumner Elementary School, the District has provided a Total Project Budget of \$2,416,338, which includes a construction cost of \$1,981,799. Construction costs include:
 - \$923,356 (\$126.59/sq. ft.) for the aluminum windows
 - \$91,422 for window sills
 - \$49.347 for window trim
 - \$19,224 for window lintels
 - \$151,986 for masonry at the windows
 - \$110,327 for masonry at the water table (ineligible for reimbursement)
 - \$48,969 for exterior doors
 - \$107,931 for removal and reinstallation of HVAC equipment at the windows
 - \$31,694 for window shades
 - \$92,182 for window security screens
 - \$67,881 for American with Disabilities Act compliance scope
 - \$287,480 for hazardous material abatement and other associated window/door replacement work

- 2) At the Curley K-8 School, the District has provided a Total Project Budget of \$4,240,582, which includes a construction cost of \$3,648,625. Construction costs include:
 - \$1,980,228 (\$121.63/sq. ft.) for the aluminum windows
 - \$174,161 for window sills
 - \$75,821 for window trim
 - \$41,702 for window lintels
 - \$125,263 for masonry at the windows
 - \$84,650 for precast panels located above select windows
 - \$120,401 for exterior doors
 - \$137,556 for removal and reinstallation of HVAC equipment at the windows
 - \$103,808 for window shades
 - \$182,856 for window security screens
 - \$99,199 for American with Disabilities Act compliance scope
 - \$522,980 for hazardous material abatement and other associated window/door replacement work
- 3) At the David A. Ellis School, the District has provided a Total Project Budget of \$3,689,605, which includes a construction cost of \$3,188,544. Construction costs include:
 - \$1,262,181 (\$143.43/sq. ft.) for the aluminum windows
 - \$387,026 for window sills
 - \$439,783 for window trim
 - \$41,693 for window lintels
 - \$59,602 for masonry at the windows
 - \$67,554 for exterior doors
 - \$115,336 for removal and reinstallation of HVAC equipment at the windows
 - \$45,733 for window shades
 - \$119,548 for window security screens
 - \$58,814 for ceiling and lighting removal and replacement in Assembly area due to window replacement
 - \$111,611 for ceiling removal and reinstall due to window replacement
 - \$479,663 for hazardous material abatement and other associated window/door replacement work
- 4) At the Donald McKay K-8 School, the District has provided a Total Project Budget of \$3,123,287, which includes a construction cost of \$2,652,148. Construction costs include:
 - \$1,150,740 (\$129.17/sq. ft.) for the aluminum windows
 - \$110.191 for window sills
 - \$331,012 for window trim
 - \$6.907 for window lintels
 - \$160,393 for masonry at the windows
 - \$33.811 for exterior doors

- \$67,691 for removal and reinstallation of HVAC equipment at the windows
- \$45,270 for window shades
- \$124,745 for window security screens
- \$77,361 for lighting removal and reinstall due to window replacement
- \$192,325 for ceiling removal and reinstall due to window replacement
- \$351,702 for hazardous material abatement and other associated window/door replacement work
- 5) At Dorchester Academy, the District has provided a Total Project Budget of \$5,208,311, which includes a construction cost of \$4,524,620. Construction costs include:

 - \$495.866 for window trim
 - \$8,413 for window lintels
 - \$169,684 for masonry at the windows
 - \$93,420 for exterior doors
 - \$67,302 for removal and reinstallation of HVAC equipment at the windows
 - \$39,760 for window shades
 - \$227,402 for window security screens
 - \$293,090 for ceiling removal and reinstall due to window replacement

- 6) At the Grover Cleveland Middle School, the District has provided a Total Project Budget of \$2,311,697, which includes a construction cost of \$1,895,564. Construction costs include:
 - \$866,192 (\$127.46/sq. ft.) for the aluminum windows
 - \$80,732 for window sills
 - \$51,309 for window trim
 - \$126,189 for window lintels
 - \$21,181 for masonry at the windows
 - \$57,727 for exterior doors
 - \$69,691 for removal and reinstallation of HVAC equipment at the windows
 - \$34,278 for window shades
 - \$92,000 for window security screens
 - \$13,047 for ceiling removal and reinstall due to window replacement
 - \$483,218 for hazardous material abatement and other associated window/door replacement work
- 7) At the Young Achievers Science and Math Pilot K-8 School, the District has provided a Total Project Budget of \$4,153,343, which includes a construction cost of \$3,597,623. Construction costs include:
 - \$1,774,539 (\$123.34/sq. ft.) for the aluminum windows

- \$162,378 for window sills
- \$86.609 for window trim
- \$171,294 for window lintels
- \$398,272 for masonry at the windows
- \$67,418 for exterior doors
- \$150,362 for removal and reinstallation of HVAC equipment at the windows
- \$103,147 for window shades
- \$166,432 for window security screens
- \$6,624 for ceiling removal and reinstall due to window replacement
- \$66,239 for ADA compliance scope
- \$444,309 for hazardous material abatement and other associated window/door replacement work

MSBA staff recommends a combined Estimated Maximum Total Facilities Grant of \$15,590,233; however, the District may be eligible for up to an additional \$773,784 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a combined Maximum Total Facilities Grant of \$16,364,018 for: (1) a window/door replacement project at the Charles Sumner Elementary School; (2) a window/door replacement project at the Curley K-8 School; (3) a window/door replacement project at the David A. Ellis Elementary School; (4) a partial window/door replacement project at the Donald McKay K-8 School; (5) a window/door replacement project at the Grover Cleveland Middle School; and (7) a window/door replacement project at the Young Achievers Science and Math Pilot K-8 School.
