Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss the potential project's scope and budget. The District has provided a Total Project Budget of \$124,755,412, which includes an estimated construction cost of \$95,976,807 (\$625/sq. ft.). The Estimated Basis of the Total Facilities Grant will be \$67,777,406, which excludes legal fees, ineligible OPM costs associated with miscellaneous extra services and other administrative costs, ineligible costs associated with abatement of asbestos-containing floor materials, removal of underground storage tanks and associated contaminated soils, costs associated with off-site street and utility improvements, costs associated with excessive auditorium area and other ineligible spaces that exceed MSBA guidelines, construction costs in excess of \$326/sq. ft. plus eligible demolition and abatement, costs associated with swing space, costs associated with mailing and moving, costs in excess of the \$1,200 per student allowance for fixtures, furniture, and equipment, costs in excess of the \$1,200 per student allowance for technology, costs associated with the commissioning of ineligible square footage, and owner's and construction contingency costs. The MSBA and the City are both involved in continuing discussions regarding the proposed special education spaces that will be included in the new facility. Pursuant to MSBA guidelines, the Special Education Program must be reviewed and approved by the Department of Elementary and Secondary Education ("DESE"). If DESE concludes that the types or numbers of special education spaces proposed by the City are not

required for the Special Education Program, then the MSBA will request that the City re-allocate those special education spaces into other categories of the space summary, which may result in additional ineligible square footage.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$47,675,093; however, the District may be eligible for up to an additional \$1,215,527 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$48,890,620 for the Project Scope and Budget Agreement and Project Funding Agreement with the City of Boston to replace the existing Boston Arts Academy facility with a new Boston Arts Academy on the existing site.

² Does not include any grant funds for potentially eligible owner's or construction contingency expenditures; subject to MSBA review and audit.

³ Includes maximum possible owner's and construction contingency grant funds, the final amount of which, if any, shall be determined by the MSBA in its sole discretion. The MSBA does not anticipate that the District will expend all of its contingency funds on expenses that are eligible for MSBA reimbursement.
