Discussion

The OPM and Designer conducted a feasibility analysis of each facility and developed schematic designs including proposed scopes of work, schedules, and estimated budgets. The District's Designer, Architectural Engineers, Inc., recommends a boiler replacement project at the Beechwood Knoll Elementary School, a partial boiler replacement project at the Atherton Hough Elementary School, a partial boiler replacement project at the Merrymount Elementary School, and a partial boiler replacement project at the Wollaston Elementary School. The Designer has confirmed that the boilers will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analyses and proposed schedules that were provided by the District. Also, MSBA staff discussed the scopes and budgets for each project with the District and its consultants.

At the Beechwood Knoll Elementary School, the District has provided a Total Project Budget of \$723,785 which includes a construction cost of \$482,967. Construction costs include:

- \$147,680 for the new boilers (3000 MBH, gas, hot water)
- \$335,287 for demolition and other associated boiler work

At the Atherton Hough Elementary School, the District has provided a Total Project Budget of \$967,121, which includes a construction cost of \$692,906. Construction costs include:

- \$158,696 for the new boiler (3663 MBH, gas, steam)
- \$45,108 for the removal of the oil tank, sealing of the concrete, and paint work in the oil room
- \$489,102 for demolition and other associated boiler work

At the Merrymount Elementary School, the District has provided a Total Project Budget of \$994,133, which includes a construction cost of \$721,780 that combines \$664,585 for the partial boiler replacement and \$57,195 for the ADA compliance scope. Construction costs include:

- \$129,684 for the new boiler (3033 MBH, gas, steam)

- \$40,592 for the removal of the oil tank, sealing of the concrete, and paint work in the oil room
- \$494,308 for demolition and other associated boiler work
- \$57,196 for ADA compliance scope

At the Wollaston Elementary School, the District has provided a Total Project Budget of \$856,976, which includes a construction cost of \$602,864 that combines \$464,722 for the partial boiler replacement and \$138,142 for the ADA compliance scope. Construction costs include:

- \$135,982 for the new boiler (3033 MBH, gas, steam)
- \$328,740 for demolition and other associated boiler work
- \$138,142 for ADA compliance scope

MSBA staff recommends a combined Estimated Maximum Total Facilities Grant of \$2,181,158; however, the District may be eligible for up to an additional \$90,932 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a combined Maximum Total Facilities Grant of \$2,272,090 for a boiler replacement project at the Beechwood Knoll Elementary School, a partial boiler replacement project at the Atherton Hough Elementary School, a partial boiler replacement project at the Merrymount Elementary School, and a partial boiler replacement project at the Wollaston Elementary School.
