Discussion

The existing facility, serving grades 9 -12, is a 360,150 square foot comprehensive/technical high school located on Highland Avenue in Somerville. The building is co-located on the historic 13 acre Central Hill site, along with Somerville City Hall built in 1852, and the municipal library built in 1914. The High School was constructed in various phases from 1895 to 2006. The proposed project is an addition and renovation project for students in grades 9-12, including grade 6-8 Next Wave and grade 9-12 Full Circle special education day and alternative education programs and 14 Chapter 74 Career Vocational Technical Educational programs.

The Department of Elementary and Secondary Education ("DESE") has reviewed the District's proposed programming offerings and is satisfied that the District's planning for the Career/Vocational Technical Education Program offerings has been thorough and that the programs are viable.

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$255,982,704, which includes an estimated construction cost of \$199,051,710 (\$539/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$158,994,538, which excludes legal fees, ineligible costs associated with abatement of asbestos-containing floor materials and contaminated soils, costs associated with synthetic turf fields, site costs in excess of 8% of total building cost, construction costs in excess of \$312/sq. ft. plus eligible demolition and abatement, costs associated

with swing space, costs associated with mailing and moving, costs associated with ineligible construction area, costs in excess of the MSBA Fixtures, Furniture and Equipment cost caps, and owner's and construction contingency costs.

The reimbursement rate of 75.29%, which is included in the above recommendation is based upon the Community Poverty Factor Points that were allocated to the City of Somerville for Calendar Year 2015. If the Board of Directors has not authorized the Executive Director to use the Calendar Year 2015 points to calculate the reimbursement rate for the proposed Somerville High School Project, the total reimbursement rate using the Calendar Year 2017 Community Poverty Factor Points would decrease to 73.87%, and the grant amounts would be reduced accordingly.

Based on using the CY 15 Poverty Factor Points, MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$119,706,988; however, the District may be eligible for up to an additional \$4,256,319 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$123,963,307 for the Project Scope and Budget Agreement and Project Funding Agreement for an addition and renovation project at the Somerville High School.

If the Board of Directors has not authorized the Executive Director to use the Calendar Year 2015 Community Poverty Factor points to calculate the reimbursement rate for the proposed Somerville High School Project, MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$117,449,265; however, the District may be eligible for up to an additional \$4,176,043 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, if the Board of Directors has not authorized the Executive
