



CAPITAL PIPELINE OVERVIEW

Status of Current Projects

A total of 328 projects that have received Invitations from the Board of Directors ("Board") to collaborate with the Massachusetts School Building Authority ("MSBA") are currently in the MSBA's Eligibility Period and Capital Pipeline. The summary chart provides the number of projects in Eligibility Period and each phase of the Capital Pipeline. The following activities are scheduled for FY 18:

- An informational update on the selection of Owner's Project Managers and Designers for the Accelerated Repair Program is anticipated for the February 2018 Board of Directors Meeting.
- The 2018 SOI submittal period opened on January 5, 2018. The submittal period will close on February 16, 2018 for the Accelerated Repair Program ("ARP") and on April 6, 2018 for the Core Program.
- Staff has procured a consultant to review the guidelines for science labs in elementary and middle schools and to recommend updates to the high school science lab guidelines to align with the Next Generation Science Standards. Contract preparation and execution is underway and the kick-off is anticipated in March 2018.
- Updates to staff reviews for changes associated with limited scope repair projects; updates to the Educational Profile Questionnaire; and updates to the post-occupancy review are anticipated in the second half of FY 18.

2018 Progress Report

- Statement of Interest ("SOI") 2018
 - The 2018 SOI submittal period opened on January 5, 2018. The submittal period will close on February 16, 2018 for the Accelerated Repair Program ("ARP") and April 6, 2018 for the Core Program.
- Eligibility Period
 - o 23 districts are currently in Eligibility Period.
 - Six districts from the 2016 Core SOI Invitations are tentatively scheduled to be recommended for Invitation to Feasibility Study at the February 14, 2018 Board Meeting. Additionally, two districts from the 2016 SOI Core SOI Invitations are tentatively scheduled to be recommended for Invitation to Feasibility Study at the April 10, 2018 Board Meeting.
 - The first group of districts from the 2017 Core SOI Invitations will commence Eligibility Period as of May 1, 2018.
- Feasibility Study/Schematic Design
 - One district received MSBA approval for their selection of an Owner's Project Manager ("OPM").
 - o Four districts completed their Designer Selections.
 - 14 districts anticipate that they will submit their preferred schematic solutions between February 2018 and June 2018.
 - 11 districts are anticipating that they will submit for Project Funding Agreements between February 2018 and June 2018.
- Accelerated Repair Program ("ARP")
 - Six districts from the 2017 ARP SOI Invitations will be presented for Project Funding Agreements at the 2018 February Board Meeting.
- Construction Costs Core Program
 - o MSBA staff anticipates that ten projects will solicit construction bids in 2018.
- Substantial Completion
 - o 11 projects are projected to reach substantial completion in 2018.

STATEMENTS OF INTEREST (SOIs)

2018 SOI Process

The 2017 SOI submittal period opened on January 5, 2018. The deadline to file SOIs for consideration in the ARP, which is primarily for the repair and/or replacement of roofs, windows/doors, and/or boilers in an otherwise structurally sound facility, is Friday, February 16, 2018. The deadline to file SOIs for consideration in the Core Program, which is primarily for projects beyond the scope of ARP, including extensive repairs, renovations, addition/renovations, and new school construction, is Friday, April 6, 2018.

CORE PROGRAM

ELIGIBILITY PERIOD

There are 23 districts in Eligibility Period, with seven districts having secured their funding.

An agreed-upon enrollment is a key pre-requisite for the MSBA to commence a Feasibility Study with a district. To begin the enrollment projection process, a district must file enrollment information utilizing the MSBA's online enrollment projection tool. Eight of the districts currently in Eligibility Period have completed their online enrollment projection information.

Designer Selection

Once a district has procured an OPM and Designer, the district and the district's consultants must complete two Feasibility Study submittals, the Preliminary Design Program, and the Preferred Schematic Report, prior to Board consideration to proceed into Schematic Design. Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that 14 districts will appear before the Board for their Preferred Schematic Designs authorizations at the February, April, and June Board Meetings.

DESIGN DEVELOPMENT

After a district has secured local funding and has entered into a Project Funding Agreement ("PFA") with the MSBA, the district enters into the Design Development Phase. Currently, there are 26 projects in the Design Development Phase with a total estimated construction cost of approximately \$885 million. Of those 26 projects, 16 are ARP Projects and 10 are Core Program Projects. The 10 Core Program Projects in Design Development have a total estimated construction cost of approximately \$831 million and are listed below.



CONSTRUCTION

When a district issues a Notice to Proceed, the project is advanced to the Construction Phase. Currently, there are 45 projects in the Construction Phase with a total estimated construction cost of \$1.17 billion. Of those 45 projects, 25 are ARP Projects, and 20 are Core Program Projects. This does not include the 53 projects that have reached substantial completion and are currently in the Building Complete Phase. The 20 Core Program Projects have a total estimated construction cost of \$1.12 billion and are listed below.

^{*}Note: Westfield, Abner Gibbs Elementary School, stopped construction in December of 2012 due to a preliminary injunction based upon project site status as Article 97 "Protected Land". The Supreme Judicial Court ruled that the proposed site is subject to provisions of Article 97. The MSBA is working with the District and will present its recommendations at a future Board of Directors meeting upon finalization.

Amendment to the Project Funding Agreement (PFA)

Upon receipt of construction bids or the execution of a GMP, a district submits the Contractor's Schedule of Values to the MSBA. MSBA staff and the district collaborate to reconcile the construction costs from the schedule of values against the estimated construction budget and an amendment to the PFA is executed to reflect bid costs. The chart, shown below, is the number of amendments to PFAs, listed by fiscal year.









Status of Green Repair Program

The Green Repair Program resulted in PFA authorizations totaling \$366,647,226 in Total Project Costs and \$222,889,218 in MSBA grants. Of the 189 projects, 184 have been approved for final grant payments. The five projects that were not previously approved for final grant payments are substantially complete and require Final Audit.

Accelerated Repair Projects – Schedule Extension Update

The MSBA has granted districts conditional extensions to their PFAs pending compliance with the following stipulations:

- The district must submit a detailed, revised, construction timeline that explains how the work will be completed at each school; and
- Any costs that are related to a district requesting an extension to the construction schedule will be the sole responsibility of the district and those costs are categorically ineligible for reimbursement by the MSBA.

Schedule delays for these districts can be attributed to local funding issues, lead time for windows, and construction delays on site. In no event have the extended schedules resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board.

Four of the 48 2016 ARP Projects revised their construction schedules and are scheduled to be completed in 2018. Staff has reported previously on the shaded projects listed below.

Upon receiving the Board's approval of the Project Scope and Budget, the MSBA and participating districts enter into a Project Funding Agreement, which establishes the Total Project Budget and the Estimated Maximum Total Facilities Grant for an approved project. Staff has reported on budget increases for the 21 projects shaded below at previous Board Meetings. No shading appears where project information is new or updated since the previous Board Meeting. In no event has the increase in budget resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board. Since the last report, no projects have been updated in the chart.


