RE: Reconciliation of Approved Projects to the Annual Program Funding Cap

In accordance with the administrative procedures presented at the May 12, 2017 Board of Directors (the "Board") meeting, this memorandum summarizes the annual reconciliation that compares the total grants for projects approved by the Board to the calculated annual program funding cap for each fiscal year. This memorandum provides the reconciliation for fiscal year 2018 ("FY 18") and provides the total remaining funds for which the total grants for approved projects is less than the FY 18 annual cap. This memorandum recommends that the Board preapprove these remaining FY 18 funds that could be applied to either one or more projects that are anticipated for approval in fiscal year 2019 ("FY 19").

Discussion

The MSBA statute places a limit upon the estimated amount of grants that can be approved by the MSBA during a fiscal year. That annual estimated grant limit ("grant cap") is adjusted each year by an amount that is equal to the lesser of the rate of growth, by percentage, of dedicated sales tax revenues or 4.5 per cent. In May 2017, the MSBA implemented grant cap reconciliation procedures which enable the MSBA to annually calculate and capture unallocated grant cap space at the close of each fiscal year. If there is any unallocated grant space remaining at the close of the fiscal year, the Board of Directors is asked to approve that unallocated grant cap space for the funding of future Projects.

In accordance with the above procedures, staff have completed the annual reconciliation for projects approved in FY18 and summaries of available cap space and approved estimated grants are presented below:

Staff note that at the April 10, 2018 Board meeting the reconciliation amount inadvertently carried a \$10,000,000 credit for the removal of Clarksburg. However, the removal of the Statement of Interest for the Clarksburg Elementary School occurs within the same fiscal year as the board authorization and therefore the Clarksburg project removal is accounted for below in the summary of approved estimated grants shown in Attachment C.

Staff note that Attachment C has been adjusted to reflect three project removals approved in FY 18: Clarksburg, Tisbury and Ipswich. In addition, the Bristol County Agricultural School, approved at the June 27, 2018 Board meeting, has been allocated to the annual cap effective as of July 1, 2018.

Based on current schedules provided, MSBA staff anticipate higher grant activity in FY 19 than provided for in the projected FY 19 annual cap. This pre-approval will be in addition to the FY 19 cap and will allow MSBA staff to move districts forward to maximize the number of projects approved within each fiscal year.

Unused Cap Space from FY 18: \$21,948,007 Estimated Annual Cap Space for FY 19: +\$587,767,716 Estimated Cap Space available for authorization in FY 19¹: \$609,715,723

RECOMMENDATION: Based on the review and findings described above staff recommends that the Board pre-approve \$21,948,007 from the remaining FY 18 funds that could be applied to either one or more projects that are anticipated for approval in FY19.
