If the District does not meet the requirements for the energy efficiency, the District will not qualify for these incentive points, and the MSBA will adjust the reimbursement rate accordingly.

Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$94,839,543, which includes an estimated construction cost of \$74,886,581 (\$504.55/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$61,933,167, which excludes legal fees, costs associated with abatement of asbestos-containing floor materials, ineligible costs associated with the removal of an underground storage tank, site costs in excess of 8% of total building cost, construction costs associated with ineligible Community Room and Central Administration spaces, construction costs in excess of \$333/sq. ft. plus eligible demolition and abatement, costs associated with mailing and moving, costs in excess of the \$1,200 per student allowance for furnishings, fittings and equipment, costs in excess of the \$1,200 per student allowance for technology, and owner's and construction contingency costs.

Additionally, the anticipated relocation of current students from the Moreau Hall Elementary School to the new facility will result in the MSBA recovering a portion of state funds previously paid to the District for the roof repair project at Moreau Hall Elementary School (MSBA ID# 201300880020), which was completed in 2014. The MSBA has calculated this recovery of funds to be \$232,668. Also, costs associated with the commissioning of ineligible square footage will result in the recovery of a portion of the overall commissioning cost. The MSBA has calculated this recovery of funds to be \$5,692. Both cost recovery amounts have been deducted from the Estimated Maximum Total Facilities Grant and the Maximum Total Facilities Grant.

The District presented an update of the proposed project to the MSBA Facilities Assessment Subcommittee ("FAS") on October 2, 2019. At that meeting, members of the FAS discussed the following topics: tuition-based Kindergarten programming; material selection of exterior learning and play spaces to accommodate users with different mobility needs; the need to budget for maintenance costs associated with exterior learning and play spaces; the number of toilets provided for grades 1 and 2; the proposed ramp landing in relationship to the Media Center; the location and scale of the cafeteria servery; the concept of universal design; and the impact that the proposed main ramp has or will have on school schedule, transition times, safety, and student experience.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$34,400,860; however, the District may be eligible for up to an additional \$1,627,024 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$36,027,884 for the Project Scope and Budget Agreement and Project Funding Agreement to replace the existing Center Elementary School, Moreau Hall Elementary School, and Parkview Elementary School with a new district-wide grades PK-2 facility on the site of the existing Parkview Elementary School.
