Recommendation

That the Executive Director be authorized to enter into a Project Scope and Budget Agreement and a Project Funding Agreement with the Town of Marblehead (the "District") to replace the existing Elbridge Gerry Elementary School, the L.H. Coffin School, and the Upper and Lower Malcolm L. Bell Schools with a new PK-3 elementary school facility on the existing Bell Elementary School site.

Further, based on the timing of the District's annual Town Meeting, which will be held on May 6, 2019 and the subsequent debt exclusion vote to be held mid-June, the District has requested a 15-day extension to its 120-day deadline to appropriate its full project funds. Based on the information provided, MSBA staff support an extension of 15 days beyond the initial 120-day deadline, in furtherance of the District's efforts to secure local authorization for the proposed project.

Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$55,594,767, which includes an estimated construction cost of \$43,786,426 (\$534/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$36,304,090, which excludes: Legal fees; OPM fees in excess of 3.5% of construction costs and fees associated with ineligible Health and Physical Education areas beyond guidelines; Designer fees associated with ineligible Health and Physical Education areas beyond guidelines; ineligible costs associated with abatement of asbestoscontaining floor materials; site costs in excess of 8% of total building cost; construction costs associated with ineligible Health and Physical Education areas beyond guidelines; costs associated with ineligible square footage in Art and Music, Medical, Administration and Guidance, and Custodial and Maintenance space beyond guidelines; cost associated with the commissioning of ineligible square footage; construction costs in excess of \$333/sq. ft. plus eligible demolition and abatement; costs associated with swing space; costs associated with mailing and moving; costs in excess of the \$1,200 per student allowance for fixtures, furniture, and equipment; costs in excess of the \$1,200 per student allowance for technology, and owner's and construction contingency costs.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$13,997,188; however, the District may be eligible for up to an additional \$281,686 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$14,278,874 for the Project Scope and Budget Agreement and Project Funding Agreement to replace the existing Elbridge Gerry Elementary School, L.H. Coffin School, and the Upper and Lower Malcolm L. Bell Schools with a new PK-3 elementary school facility on the existing Bell Elementary School site.
