CAPITAL PIPELINE OVERVIEW

Status of Current Projects

A total of 323 projects that have received invitations from the Board of Directors ("Board") to collaborate with the Massachusetts School Building Authority ("MSBA") are currently in the MSBA's Eligibility Period and Capital Pipeline. The summary chart provides the number of projects in Eligibility Period and each phase of the Capital Pipeline. The following activities are scheduled for FY 19:

- The 2019 SOI submittal period opened on January 4, 2019. The deadline to file for consideration in the Accelerated Repair Program ("ARP") is Friday, February 15, 2019. The deadline to file for consideration in the Core Program is Friday, April 12, 2019.

 - Cost RFR Responses to re-advertised RFR received October 31, 2018. Staff recommendation to the Executive Director is underway.
 - Review of enrollment methodology Staff recommendation to the Executive Director approved.

2019 Progress Report

- Statement of Interest ("SOI") 2019
 - The 2019 SOI submittal period opened on January 4, 2019. The deadline to file for consideration in the Accelerated Repair Program ("ARP") is Friday, February 15, 2019. The deadline to file for consideration in the Core Program is Friday, April 12, 2019.
- Eligibility Period
 - o There are 21 districts in Eligibility Period.
 - For the 2017 SOIs, four SOIs commenced Eligibility Period as of April 2, 2018, three SOIs commenced as of May 1, 2018, four commenced as of June 1, 2018, and four commenced as of July 1, 2018.
 - Three of the 2017 SOIs will be recommended for invitation to feasibility study at the December
 Board meeting and the remaining five are anticipated for the April 2019 Board meeting.
- Feasibility Study/Schematic Design
 - Seven districts anticipated for MSBA approval for selection of an Owner's Project Manager ("OPM") commencing in March 2019.
 - Two districts completed Designer Selection. Three districts are in the process of procuring a Designer.
 - Eleven districts are anticipating submittals for the preferred schematic solutions between February 2019 and June 2019.
 - Nine districts are anticipating submittals for Project Funding Agreements between February 2019 and June 2019.
- Accelerated Repair Program ("ARP")
 - 22 of 23 Districts from the 2018 ARP invitations have completed their initial documents and have received consultant assignments. The remaining two Districts received extensions for their initial documents.
- Construction Costs Core Program
 - o MSBA staff anticipates eleven projects will have bid in 2018.
- Substantial Completion
 - o Thirteen projects are scheduled to reach substantial completion in 2019.

STATEMENTS OF INTEREST (SOIs)

2019 SOI Process

The 2019 SOI submittal period opened on January 4, 2019. The deadline to file SOIs for consideration in the ARP, which is primarily for the replacement of roofs, windows/doors, and/or boilers in an otherwise structurally sound facility, is Friday, February 15, 2019. The deadline to file SOIs for consideration in the Core Program, which is primarily for projects beyond the scope of ARP, including extensive repairs, renovations, addition/renovations, and new school construction, is Friday, April 12, 2019.

CORE PROGRAM

ELIGIBILITY PERIOD

There are 21 districts in Eligibility Period, with eight districts having secured their funding.

An agreed-upon enrollment is a key pre-requisite for the MSBA to commence a Feasibility Study with a district. To begin the enrollment projection process, a district must file enrollment information utilizing the MSBA's online enrollment projection tool. Nine of the 21 districts in Eligibility Period have completed their online enrollment projection information.

Owner's Project Manager ("OPM") Selection

Designer Selection

After a district has selected and executed a contract with an OPM, the district selects a Designer by utilizing either a local designer selection process for projects under \$5 million or the MSBA's Designer Selection Panel ("DSP") for projects over \$5 million. Once a district has procured an OPM and Designer, the district and the district's consultants must complete two Feasibility Study submittals, the Preliminary Design Program and the Preferred Schematic Report, prior to Board consideration to proceed into Schematic Design. Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that eleven districts will appear before the board for their Preferred Schematic Designs authorizations at the February, April, and June Board Meetings.

DESIGN DEVELOPMENT

After a district has secured local funding and has entered into a Project Funding Agreement ("PFA") with the MSBA, the district enters into the Design Development Phase. Currently, there are 28 projects in the Design Development Phase with a total estimated construction cost of approximately \$1.89 billion. Of those 28 projects, 8 are ARP Projects and 20 are Core Program Projects. The 20 Core Program Projects in Design Development have a total estimated construction cost of approximately \$1.87 billion and are listed below.



CONSTRUCTION

When a district issues a Notice to Proceed, the project is advanced to the Construction Phase. Currently, there are 56 projects in the Construction Phase with a total estimated construction cost of \$1.64 billion. Of those 56 projects, 35 are ARP Projects, and 21 are Core Program Projects. This does not include the 45 projects that have reached substantial completion and are currently in the Building Complete Phase. The 21 Core Program Projects have a total estimated construction cost of \$1.54 billion and are listed below.

Amendment to the Project Funding Agreement (PFA)

Upon receipt of construction bids or the execution of a GMP, a district submits the Contractor's Schedule of Values to the MSBA. MSBA staff and the district collaborate to reconcile the construction costs from the schedule of values against the estimated construction budget and an amendment to the PFA is executed to reflect bid costs. ACCELERATED REPAIR PROGRAM




The photo above depicts the Roberta G Doering Middle School in Agawam serving 572 students. The project replaced a 55-year-old boiler and will extend the useful life of the 97-year-old building. The project reached Substantial Completion in September 2017 and is being brought to the February 2019 Board of Directors meeting for Final Audit Approval.

Currently, there are **287** projects either active or completed in the ARP. The **287** projects are located in **112** districts, many of whom have been invited to ARP multiple times. All new information that has been updated since the last report is *italicized and bolded*.








2015 ARP Status Chart

Status of Green Repair Program

The Green Repair Program resulted in PFA authorizations totaling \$366,647,226 in Total Project Costs and \$222,889,218 in MSBA grants. As of the October 31st Board of Directors Meeting, all 189 projects from 193 districts have been approved for final grant payments.

Accelerated Repair Projects – Schedule Extension Update

The MSBA has granted districts conditional extensions to their PFAs pending compliance with the following stipulations:

- The district must submit a detailed, revised, construction timeline that explains how the work will be completed at each school; and
- Any costs that are related to a district requesting an extension to the construction schedule will be the sole responsibility of the district and those costs are categorically ineligible for reimbursement by the MSBA.

Schedule delays for these districts can be attributed to local funding issues, lead time for windows, and construction delays on site. In no event have the extended schedules resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board.

One of the 43 2015 ARP Projects revised their construction schedule twice and was scheduled to be completed in 2018. Staff has reported previously on the shaded schedule extension listed below.

In no event has the increase in budget resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board. Since the last report, no projects have been updated in the chart.






