

CAPITAL PIPELINE OVERVIEW

Status of Current Projects

A total of 323 projects that have received invitations from the Board of Directors ("Board") to collaborate with the Massachusetts School Building Authority ("MSBA") are currently in the MSBA's Eligibility Period and Capital Pipeline. The summary chart provides the number of projects in Eligibility Period and each phase of the Capital Pipeline. 2018 Progress Report

- Statement of Interest ("SOI") 2019
 - The 2019 SOI submittal period opened on January 4, 2019. The deadline to file for consideration in the Accelerated Repair Program ("ARP") was Friday, February 15, 2019. 83 ARP SOIs were received and are under evaluation. The deadline to file for consideration in the Core Program is Friday, April 12, 2019.
- Eligibility Period
 - There are 18 districts in Eligibility Period.
 - For the 2017 SOIs, four SOIs commenced Eligibility Period as of April 2, 2018, three SOIs commenced as of May 1, 2018, four commenced as of June 1, 2018, and four commenced as of July 1, 2018.
 - Three of the 2017 SOIs will be recommended for invitation to feasibility study at the December Board meeting and the remaining two are anticipated for the June 2019 Board meeting.
- Feasibility Study/Schematic Design
 - Two districts completed OPM Selection. Nine districts anticipated for MSBA approval for selection of an Owner's Project Manager ("OPM").
 - Two districts completed Designer Selection. Three districts are in the process of procuring a Designer.
 - Nine districts are anticipating submittals for the preferred schematic solutions between April 2019 and August 2019.
 - Eleven districts are anticipating submittals for Project Funding Agreements between February 2019 and June 2019.
- Accelerated Repair Program ("ARP")
 - 23 districts from the 2018 ARP invitations have completed their initial documents and have received consultant assignments. 9 districts received PFA approval at the February 2019 Board meeting.
- Construction Costs Core Program
 - MSBA staff anticipates twenty projects will bid in 2019.
- Substantial Completion
 - Thirteen projects are scheduled to reach substantial completion in 2019.

STATEMENTS OF INTEREST (SOIs)

2019 SOI Process

The 2019 SOI submittal period opened on January 4, 2019. The deadline to file SOIs for consideration into the ARP, which is primarily for the replacement of roofs, windows/doors, and/or boilers in an otherwise structurally sound facility, was Friday, February 15, 2019. The MSBA is reviewing the 83 ARP SOIs submitted and anticipates recommendations into the ARP at the June 26 Board meeting. The deadline to file SOIs for consideration into the Core Program, which is primarily for projects beyond the scope of ARP, including extensive repairs, renovations, addition/renovations, and new school construction, is Friday, April 12, 2019.

CORE PROGRAM

ELIGIBILITY PERIOD

There are 18 districts in Eligibility Period, with seven districts having secured their funding.

An agreed-upon enrollment is a key pre-requisite for the MSBA to commence a Feasibility Study with a district. To begin the enrollment projection process, a district must file enrollment information utilizing the MSBA's online enrollment projection tool. Six of the 18 districts in Eligibility Period have completed their online enrollment projection information.

Designer Selection

After a district has selected and executed a contract with an OPM, the district selects a Designer by utilizing either a local designer selection process for projects under \$5 million or the MSBA's Designer Selection Panel ("DSP") for projects over \$5 million. Once a district has procured an OPM and Designer, the district and the district's consultants must complete two Feasibility Study submittals, the Preliminary Design Program and the Preferred Schematic Report, prior to Board consideration to proceed into Schematic Design. Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that nine districts will appear before the board for their Preferred Schematic Designs authorizations at the April, June, and August Board Meetings.

DESIGN DEVELOPMENT

After a district has secured local funding and has entered into a Project Funding Agreement ("PFA") with the MSBA, the district enters into the Design Development Phase. Currently, there are 27 projects in the Design Development Phase with a total estimated construction cost of approximately \$1.80 billion. Of those 27 projects, 8 are ARP Projects and 19 are Core Program Projects. The 19 Core Program Projects in Design Development have a total estimated construction cost of approximately \$1.78 billion and are listed below.

District Design Submittals

During Design Development, districts submit three design submittals (Design Development, 60% Construction Documents, and 90% Construction Documents) for MSBA review. MSBA staff review documents to ensure the project is still in compliance with the PFA. Based on the most recent data and schedules provided by the districts, 20 projects are scheduled to bid in 2019, and eight projects are scheduled to bid in 2020.



Kennedy Middle School, the Middleborough High School, and the Taunton Mulcahey Elementary School are the new construction projects that have received bids since the last report prepared for the February 13, 2018 Board Meeting.

CONSTRUCTION

When a district issues a Notice to Proceed, the project is advanced to the Construction Phase. Currently, there are 47 projects in the Construction Phase with a total estimated construction cost of \$1.63 billion. Of those 47 projects, 25 are ARP Projects, and 22 are Core Program Projects. This does not include the 51 projects that have reached substantial completion and are currently in the Building Complete Phase. The 22 Core Program Projects have a total estimated construction cost of \$1.58 billion and are listed below.

Amendment to the Project Funding Agreement (PFA)

Upon receipt of construction bids or the execution of a GMP, a district submits the Contractor's Schedule of Values to the MSBA. MSBA staff and the district collaborate to reconcile the construction costs from the schedule of values against the estimated construction budget and an amendment to the PFA is executed to reflect bid costs. The chart, shown below, is the number of amendments to PFAs, listed by fiscal year.

CLOSEOUT

After the district's contractor finishes all project work including demolishing the old building, completing site work and finalizing commissioning, the project proceeds to the Closeout Phase. Once all the project costs have been paid by the District, the District submits its Final Request for Payment Reimbursement via the MSBA's Pro-Pay system. After the District submits all the items identified on the MSBA's Index of Final Closeout, including the Final Request for Payment Reimbursement, the MSBA initiates the Draft Audit Report and sends it to the District for its consideration. The MSBA performs the final audit to determine final total grant amounts. Final payment to the District requires the MSBA Board's approval of the final Total Facilities Grant for the project.

Currently, there are 74 projects in the Closeout Phase including 50 ARP Projects, 22 Core Program Projects and 2 Waitlist Projects. The chart, shown below, lists the 22 Core Projects by year of Substantial Completion:

ACCELERATED REPAIR PROGRAM



The photos above and below depict the before and after of the Elm Street School in Gardner, serving 554 students. The project replaced the windows, doors, and boilers and will extend the useful life of the 93-year-old building. The project reached Substantial Completion in November 2016 and is being brought to the April 2019 Board of Directors meeting for Final Audit Approval.









Accelerated Repair Projects - Schedule Extension Update

The MSBA has granted districts conditional extensions to their PFAs pending compliance with the following stipulations:

- The district must submit a detailed, revised, construction timeline that explains how the work will be completed at each school; and
- Any costs that are related to a district requesting an extension to the construction schedule will be the sole responsibility of the district and those costs are categorically ineligible for reimbursement by the MSBA.

Schedule delays for these districts can be attributed to local funding issues, lead time for windows, and construction delays on site. In no event have the extended schedules resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board.

Five of the 34 2017 ARP Projects revised their construction schedule are scheduled to be completed in 2019.

Staff has reported on budget increases for the 21 projects shaded below at previous Board Meetings. No shading appears where project information is new or updated since the previous Board Meeting. In no event has the increase in budget resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board. Since the last report, no projects have been updated in the chart.






