Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$86,585,919, which includes an estimated construction cost of \$69,181,416 (\$474/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$57,458,219 which excludes the OPM and Designer fees associated with ineligible Health and Physical Education spaces, site costs in excess of 8% of total building cost, construction costs in excess of \$333/sq. ft. plus eligible demolition and abatement, construction costs associated with ineligible square footage, costs associated with mailing and moving, construction contingency costs, and other ineligible costs.

Costs associated with the commissioning of ineligible square footage will result in the recovery of a portion of the overall commissioning cost. The MSBA has calculated this recovery of funds to be \$7,167 and this amount has been deducted from the Estimated Maximum Total Facilities Grant and the Maximum Total Facilities Grant. Additionally, the MSBA is working with the District to fully understand the District's proposed repurposing plan for the existing Braintree South Middle School facility, which will be taken offline as a middle school with the completion of the new 5-8 facility. Depending on the District's reuse plan, the MSBA may recover a portion of the grant that the District received for a Green Repair project that was completed in 2011 at the existing Braintree South Middle School. If the MSBA determines that a portion of the Green Repair project grant will be recovered, the amount will be deducted from the grant for the new 5-8 facility prior to project closeout.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$30,997,288 however, the District may be eligible for up to an additional \$1,325,225 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$32,322,513 for the Project Scope and Budget Agreement and Project Funding Agreement to replace the existing South Middle School with a new grades 5-8 facility on the existing site.

²Does not include any grant funds for potentially eligible Owner's or Construction Contingency Expenditures; subject to MSBA review and audit.

³Includes maximum possible Owner's and Construction Contingency grant funds, the final amount of which, if any, shall be determined by the MSBA in its sole discretion.
