## **Discussion**

The OPM and Designer conducted a feasibility analysis of the facility and developed a Schematic Design including a proposed scope of work, schedule, and estimated budget. The District's Designer, Johnson Roberts Associates, Inc., recommends a roof, window/door, and boiler replacement project at the Challenge and Reach Academy. The

Designer has confirmed that the scope of work will be in compliance with the MSBA's sustainability requirements.

MSBA staff reviewed the consultants' existing conditions analysis and proposed schedule that were provided by the District. Also, MSBA staff discussed the scope and budget with the District and its consultants. The District has provided a Total Project Budget of \$6,075,849, which includes a construction cost of \$4,988,468. Construction costs include:

- \$205,146 (\$23.08/sq. ft.) for a new 60-mil ethylene propylene diene terpolymer ("EPDM") roof;
- \$196,181 for associated demolition and abatement;
- \$71,725 to repoint the chimney at roof level;
- \$85,182 in roof-level carpentry and misc. metals;
- and \$89,506 in other associated roof work.
- \$865,658 (\$245.02/sq. ft.) for new aluminum windows;
- \$109,346 in associated abatement;
- \$486,630 to repoint masonry around window openings;
- \$322,656 in associated carpentry, painting, and drywall;
- \$186,117 for rock guard system at window level;
- and \$121,420 in other associated window and door work.
- \$279,560 for installation of two 3,350 MBH boilers;
- \$38,316 to remove underground storage tanks (ineligible for reimbursement);
- \$191,165 for building system controls (ineligible for reimbursement);
- \$239,742 for electrical work:
- and \$119,378 in other associated boiler work.
- \$1,380,740 in accessibility upgrades, including a new elevator and vestibule, resulting from the estimated cost of the base scope exceeding 30% of the full and fair cash value of the building (ineligible for reimbursement).

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$3,101,805; however, the District may be eligible for up to an additional \$146,691 in grant funds, subject to the MSBA's review and audit of the District's Owner's and Construction Contingency Expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$3,248,496 for the Project Funding Agreement for a roof, window/door and boiler replacement project at the Challenge and Reach Academy.
