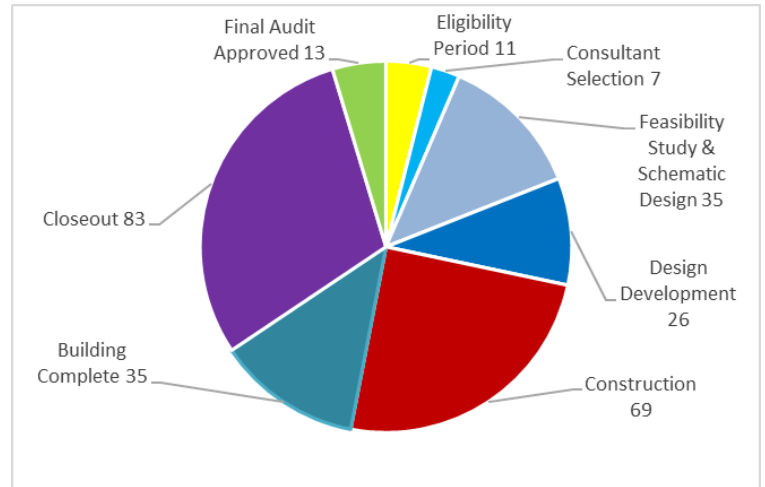

# CAPITAL PIPELINE OVERVIEW

## Status of Current Projects

A total of 279 projects that have received invitations from the Board of Directors (“Board”) to collaborate with the Massachusetts School Building Authority (“MSBA”) are currently in the MSBA’s Eligibility Period and Capital Pipeline. The summary chart provides the number of projects in Eligibility Period and each phase of the Capital Pipeline. Compared to the prior Project Overview Report, the project total has decreased by three projects which were previously removed from the Capital Pipeline. ## Capital Planning Updates:

The following activities are scheduled for FY 2021:

- Model School Program – Five responses were received on October 31, 2019. Site visits occurred at two of the schools prior to school closures. Due to ongoing public health issues, the MSBA has postponed further site visits.
- Due to staff transitions, procurement for the school survey has been postponed until at least 2021.
- The 2020 SOI submittal period opened on January 8, 2020 with ARP closing deadline on February 14, 2020. The closing deadline for Core Program SOIs was extended from April 8, 2020 to May 6, 2020.
  - Due to ongoing public health issues, the MSBA’s due diligence for the Accelerated Repair Program which includes a site visit to the school for the 30 qualifying schools has been delayed. Unlike prior years in which project invitations were approved at the June Board meeting, staff are pursuing invitations to the 2020 Accelerated Repair Program at the December 2020 or February 2021 Board meetings. The MSBA is currently coordinating with MassDOT’s Aeronautics Drone Program to obtain existing condition photographs at qualifying roof and window/door projects.
  - Due to ongoing public health issues, the MSBA’s due diligence for the Core Program, which includes senior study visits to select schools has been postponed. Unlike prior years in which project invitations were approved at the December Board meeting, a schedule for invitations into Eligibility Period is still under consideration.
- Staff continue work with the consultant to review MSBA enrollment methodologies.

## 2020 Progress Report

- \* Statements of Interest (“SOIs”) 2020
  - The 2020 SOI submittal period opened on Wednesday, January 8, 2020. The deadline to file for consideration in the Accelerated Repair Program (“ARP”) was Friday, February 14, 2020. The MSBA received 90 ARP SOIs for consideration. Due to ongoing public health issues, the MSBA’s due diligence for the ARP, which includes a site visit to the school for the 30 qualifying schools has been delayed. Unlike prior years in which project invitations were approved at the June Board meeting, staff are pursuing invitations to the 2020 Accelerated Repair Program at the December 2020 or February 2021 Board meetings. The MSBA is currently coordinating with MassDOT’s Aeronautics Drone Program to obtain existing condition photographs at qualifying roof and window/door projects. If invited, districts would then need to approve funding for the Feasibility Study/Schematic Design portion of potential projects within 60 calendar days of the date of invitation into the ARP. The deadline to file for consideration in the Core Program was extended from April 8, 2020 to May 6, 2020. The MSBA received 71 Core Program SOIs for consideration. Due to ongoing public health issues, the MSBA’s due diligence for the Core Program, which includes senior study visits to select schools has been postponed. Unlike prior years in which project invitations were approved at the December Board meeting, a schedule for invitations into Eligibility Period is still under consideration.
- \* Eligibility Period – Core Program
  - All eleven of the 2019 SOIs are currently in the Eligibility Period for the Core Program.
- \* Feasibility Study/Schematic Design – Core Program
  - Three districts completed their OPM selections and one district is tentatively scheduled to receive MSBA approval for selection of its OPM.
  - One district completed its Designer selection and six districts are in the process of procuring a Designer.
  - Twelve districts are anticipating submittals for their Preferred Schematic Solutions between October 2020 and February 2021.
  - Five districts are anticipating submittals for their Project Funding Agreements between October 2020 and February 2021.
- \* Accelerated Repair Program
  - All 25 active districts from the 2019 ARP invitations have received Project Funding Agreement authorization. Two districts previously requested and received their removal from the Accelerated Repair Program.
- \* Construction Costs – Core Program
  - In 2019, MSBA staff anticipated DBB bids or GMP executions for 22 projects. All 22 projects have received sub-bids and 20 have proceeded to DBB bids or GMP execution. The remaining two projects revised their GMP executions to 2020.
  - In 2020, MSBA staff anticipates sub-bids as well as DBB bids or GMP executions for an additional 15 projects, of which three have proceeded to DBB bids or GMP execution.
- \* Substantial Completion – Core Program
  - Nine projects are scheduled to reach substantial completion in 2020. The MSBA has received executed certificates for four of the nine projects and anticipates receipt of three additional certificates.

# STATEMENTS OF INTEREST (SOIs)

## 2020 SOI Process

The 2020 SOI submittal period opened on January 8, 2020. The deadline to file SOIs for consideration into the Accelerated Repair Program, which is primarily for the replacement of roofs, windows/doors, and/or boilers in an otherwise structurally sound facility was Friday, February 14, 2020. The MSBA received 90 ARP SOIs for consideration. The deadline to file SOIs for consideration into the Core Program, which is primarily for projects beyond the scope of ARP, including extensive repairs, renovations, additions/renovations, and new school construction, was Wednesday, May 6, 2020. The MSBA received 71 Core Program SOIs for consideration.

Due to ongoing public health issues, the MSBA’s due diligence for the Accelerated Repair Program, which would normally include a site visit to the school for the 30 qualifying schools, has been delayed. Unlike prior years in which project invitations were approved at the June Board meeting, staff are pursuing invitations to the 2020 Accelerated Repair Program at the December 2020 or February 2021 Board meetings. The MSBA is currently coordinating with MassDOT’s Aeronautics Drone Program to obtain existing condition photographs at qualifying roof and window/door projects. If invited, districts would then need to approve funding for the Feasibility Study/Schematic Design portion of potential projects within 60 calendar days of the date of invitation into the ARP. Due to ongoing public health issues, the MSBA’s due diligence for the Core Program, which includes senior study visits to select schools has been postponed. Unlike prior years in which project invitations were approved at the December Board meeting, a schedule for invitations into Eligibility Period is still under consideration.

# CORE PROGRAM

## ELIGIBILITY PERIOD

There are 11 districts in the Eligibility Period and four of those districts have secured their local funding.

An agreed-upon enrollment is a key pre-requisite for the MSBA to commence a Feasibility Study with a district. To begin the enrollment projection process, a district must file enrollment information utilizing the MSBA's online enrollment projection tool.

**CONSULTANT SELECTION**

**Owner’s Project Manager (“OPM”) Selection**

After the district has completed all Eligibility Period requirements and has received a Board Invitation to Feasibility Study, the district procures an OPM. Since the last report, Brookline, Revere and Spencer-East Brookfield RSD have completed their OPM selections (shaded in the table below). Currently, there is one district in the Capital Pipeline that is in the process of procuring an OPM.

## Designer Selection

After a district has selected and executed a contract with an OPM, the district selects a Designer by utilizing either a local designer selection process for projects under \$5 million or the MSBA’s Designer Selection Panel (“DSP”) for projects over \$5 million. Since the last report, one district has completed its Designer selection (shaded in the table below). There are currently six districts in the Capital Pipeline that are in the process of procuring a Designer.

## **FEASIBILITY STUDY**

Once a district has procured an OPM and a Designer, the district and the district's consultants must complete two Feasibility Study submittals, the Preliminary Design Program and the Preferred Schematic Report, prior to Board consideration to proceed into Schematic Design. Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that twelve districts will appear before the Board for their Preferred Schematic Design authorizations at the October 2020, December 2020, and February 2021 Board meetings.

Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that five districts will appear before the Board for Project Scope and Budget Agreement authorizations at the October 2020, December 2020, and February 2021 Board meetings.

## **COMMISSIONING**

The MSBA assigns a Commissioning Consultant after a district has secured local funding for the Board approved project. Since the last report, the MSBA has assigned Commissioning Consultants for 3 additional projects which are presented in the table below.

To date, the MSBA has executed 532 commissioning Consultant contracts, totaling \$39.7 million in commissioning fees. Construction budgets for projects being commissioned total \$12.2 billion. To date, 371 work orders have been completed.

**DESIGN DEVELOPMENT**

After a district has secured local funding and has entered into a Project Funding Agreement (“PFA”) with the MSBA, the district enters into the Design Development Phase. Currently, there are 26 projects in the Design Development Phase with a total estimated construction cost of approximately \$1.76 billion. Of those 26 projects, 10 are ARP Projects and 16 are Core Program Projects. The 16 Core Program Projects in Design Development have a total estimated construction cost of approximately \$1.74 billion and are listed below.

**District Design Submittals**

During the Design Development phase, districts will submit three design submittals (Design Development, 60% Construction Documents, and 90% Construction Documents) for the MSBA to review. MSBA staff reviews the documents to ensure the project is still in compliance with the PFA. The chart below indicates the number of submittals received and reviewed by the MSBA in each fiscal year.

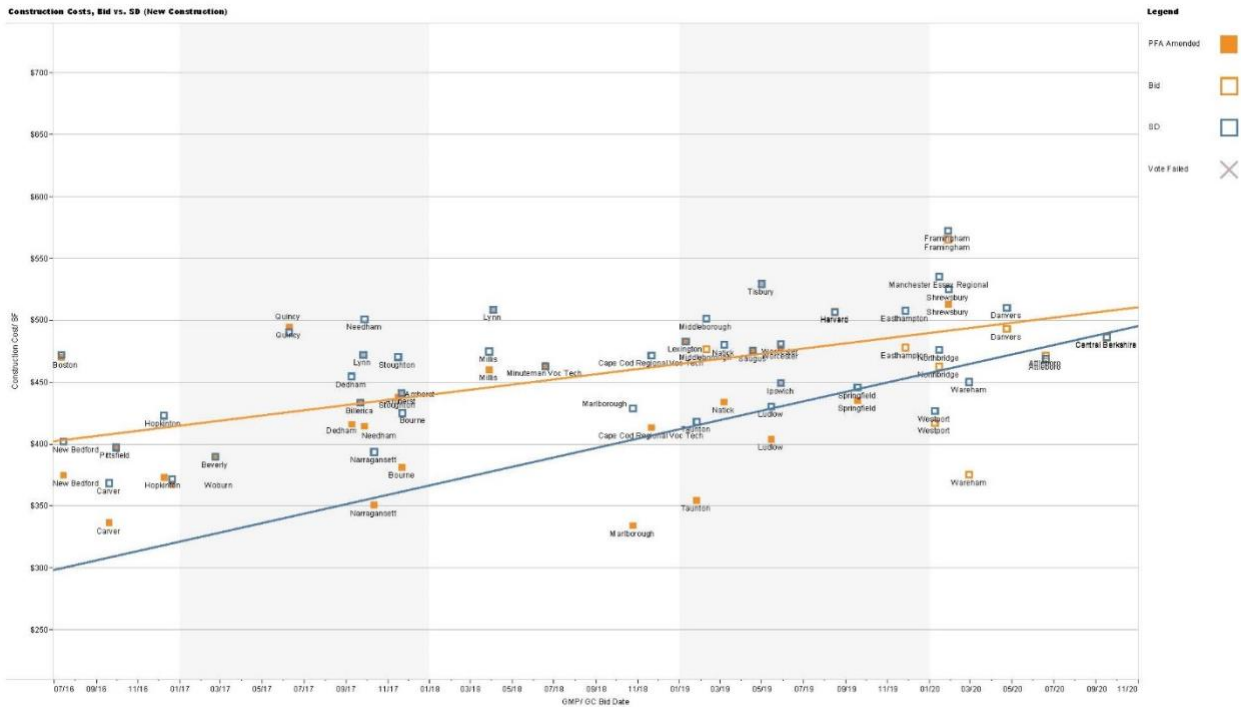
**SUMMARY OF BID DATA**

Based on the most recent data and schedules provided by districts, 15 projects are scheduled to receive sub-bids in 2020, twelve projects are scheduled to receive sub-bids in 2021, and one project is scheduled to receive sub-bids in 2022. In 2019, MSBA staff anticipated DBB bids or GMP executions for 22 projects. All 22 projects have received sub-bids and 20 have proceeded to DBB bids or GMP execution. The remaining two projects revised their GMP executions to 2020.

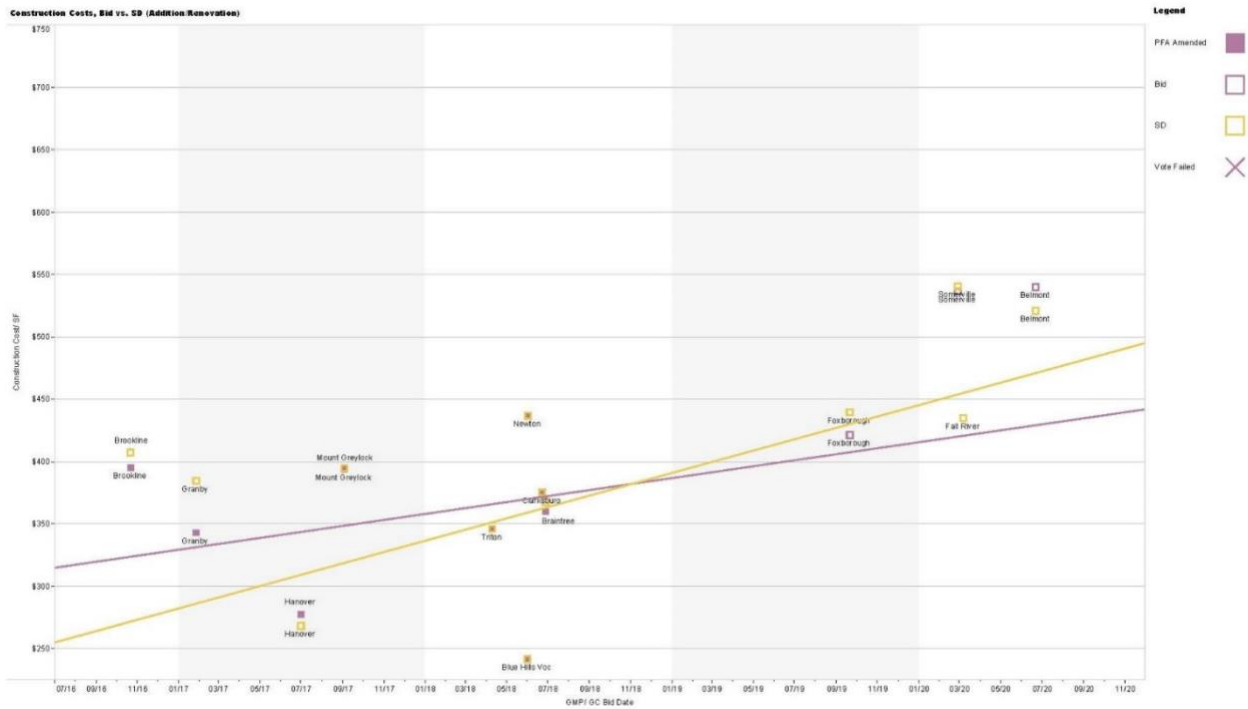

The graph below plots Schematic Design Estimates, Construction Estimates, and Construction Bid Results for new construction projects from July 2016 to present. The graph includes seven new construction projects that received bids in FY 2017, nine new construction projects that received bids in FY 2018, nine new construction projects that received bids in FY 2019, eleven new construction projects that received bids in FY 2020, and one new construction project that received bids in FY 2021. The Orange Line is a trend line for Bid Costs and the Blue Line is a trend line for Schematic Design Estimates. *Central Berkshire has received its bids, which were within its estimated construction budget, since the last report prepared for the August 26, 2020 Board meeting.*

The graph includes three addition/renovation construction projects that received bids in FY 2017, five addition/renovation construction projects that received bids in FY 2018, and four addition/renovation project that has received bids in FY 2020. The Purple Line is a trend line for Bid Costs and the Yellow Line is a trend line for Schematic Design Estimates. *There have been no new projects added since the last report prepared for the August 26, 2020 Board meeting.*

**CONSTRUCTION**

When a district with a Design-Bid-Build Construction project issues a Notice to Proceed, or when a Construction Manager At-Risk project has received bids for the concrete foundation package, the project is advanced to the Construction Phase. Currently, there are 69 projects in the Construction Phase with a total estimated construction cost of \$2.87 billion. Of those 69 projects, 41 are ARP Projects and 28 are Core Program Projects; however, this does not include the 35 projects that have reached substantial completion and are currently in the Building Complete Phase. The 28 Core Program Projects have a total estimated construction cost of \$2.81 billion and are listed below.

**Amendment to the Project Funding Agreement (PFA)**

Upon receipt of construction bids or the execution of a GMP, a district submits the Contractor’s Schedule of Values to the MSBA. MSBA staff will collaborate with the district to reconcile the construction costs from the schedule of values against the estimated construction budget. Afterwards, an amendment to the PFA is executed to reflect the bids received for those projects. The chart, shown below, is the number of amendments to PFAs listed by fiscal year.

## Substantial Completion

## **CLOSEOUT**

After the district's contractor finishes all project work including, demolishing the old building, completing site work, and finalizing commissioning, the project proceeds to the Closeout Phase. Once all the project costs have been paid by the District, the District submits its Final Request for Payment Reimbursement via the MSBA's Pro-Pay system. After the District submits all the items identified on the MSBA's Index of Final Closeout, including the Final Request for Payment Reimbursement, the MSBA initiates the Draft Audit Report and sends it to the District for its consideration. The MSBA performs the final audit to determine final total grant amounts. Final payment to the District requires the MSBA Board's approval of the final Total Facilities Grant for the project.

Currently, there are 83 projects in the Closeout Phase including 63 ARP Projects and 20 Core Program Projects. The chart, shown below, lists the Core Program Projects by year of achieved Substantial Completion:

# ACCELERATED REPAIR PROGRAM



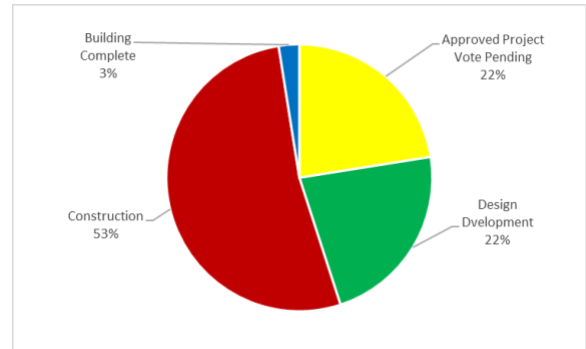

The project replaced the roof, windows/doors, and boilers, thus extending the useful life of the 63-year-old building. The project reached Substantial Completion in September 2019 and is scheduled to receive Final Audit Approval at the October 2020 Board meeting.*

Currently, there are 141 projects active in the ARP. To date, 182 projects have received Final Audit approval. The combined 323 projects are located in 127 districts, many of whom have been invited to the ARP multiple times. All the new information that has been updated since the last report is ***italicized and bolded***.

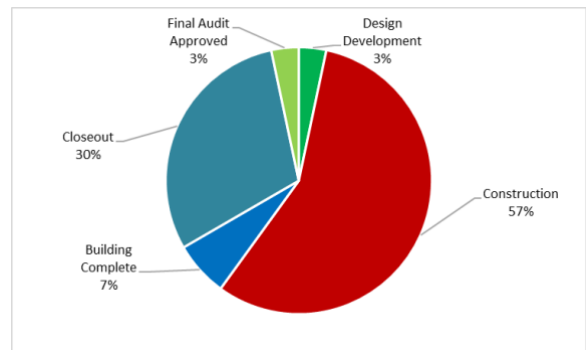

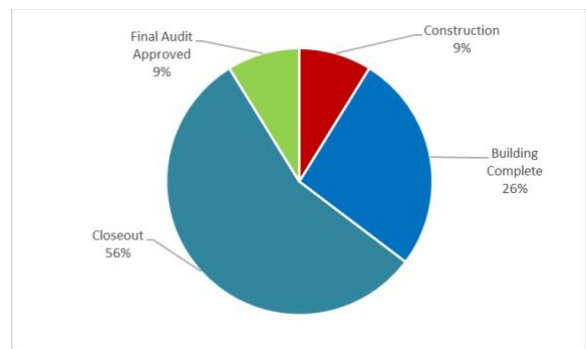

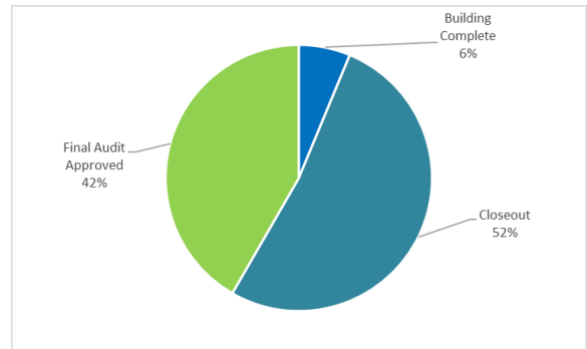

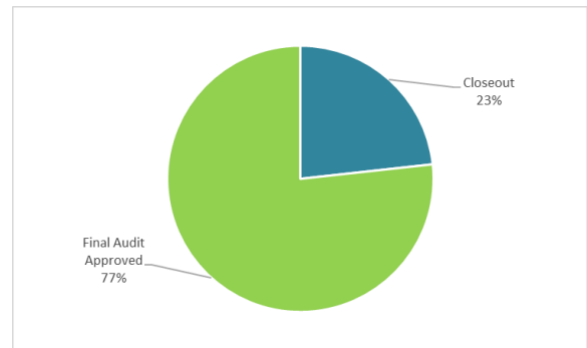

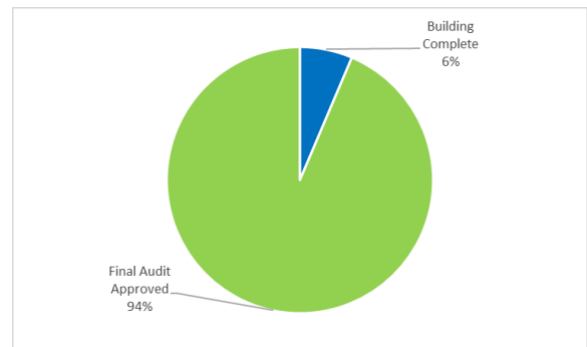

**Accelerated Repair Projects – Schedule Extension Update**

The MSBA has granted districts conditional extensions to their PFAs pending compliance with the following stipulations:

- The district must submit a detailed, revised, construction timeline that explains how the work will be completed at each school; and
- Any costs that are related to a district requesting an extension to the construction schedule will be the sole responsibility of the district, and those costs are categorically ineligible for reimbursement by the MSBA.

Schedule delays for these districts can be attributed to local funding issues, lead time for windows, and construction delays on site. In no event have the extended schedules resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board.

Six of the 34 2017 ARP Projects revised their construction schedules to reflect substantial completion in 2021 or beyond. Staff has reported previously on the shaded projects listed below, which remain in Construction or Design Development.

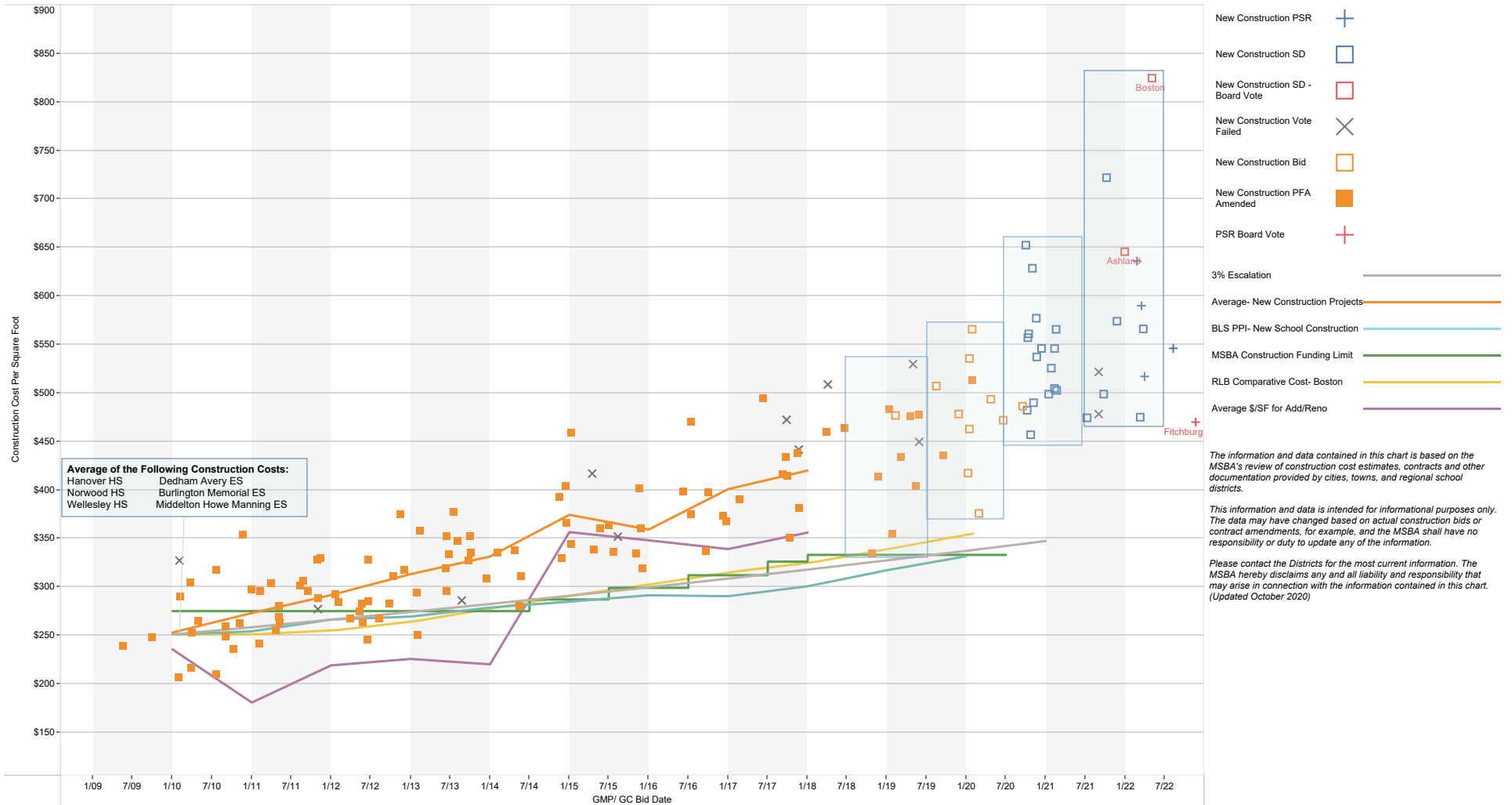

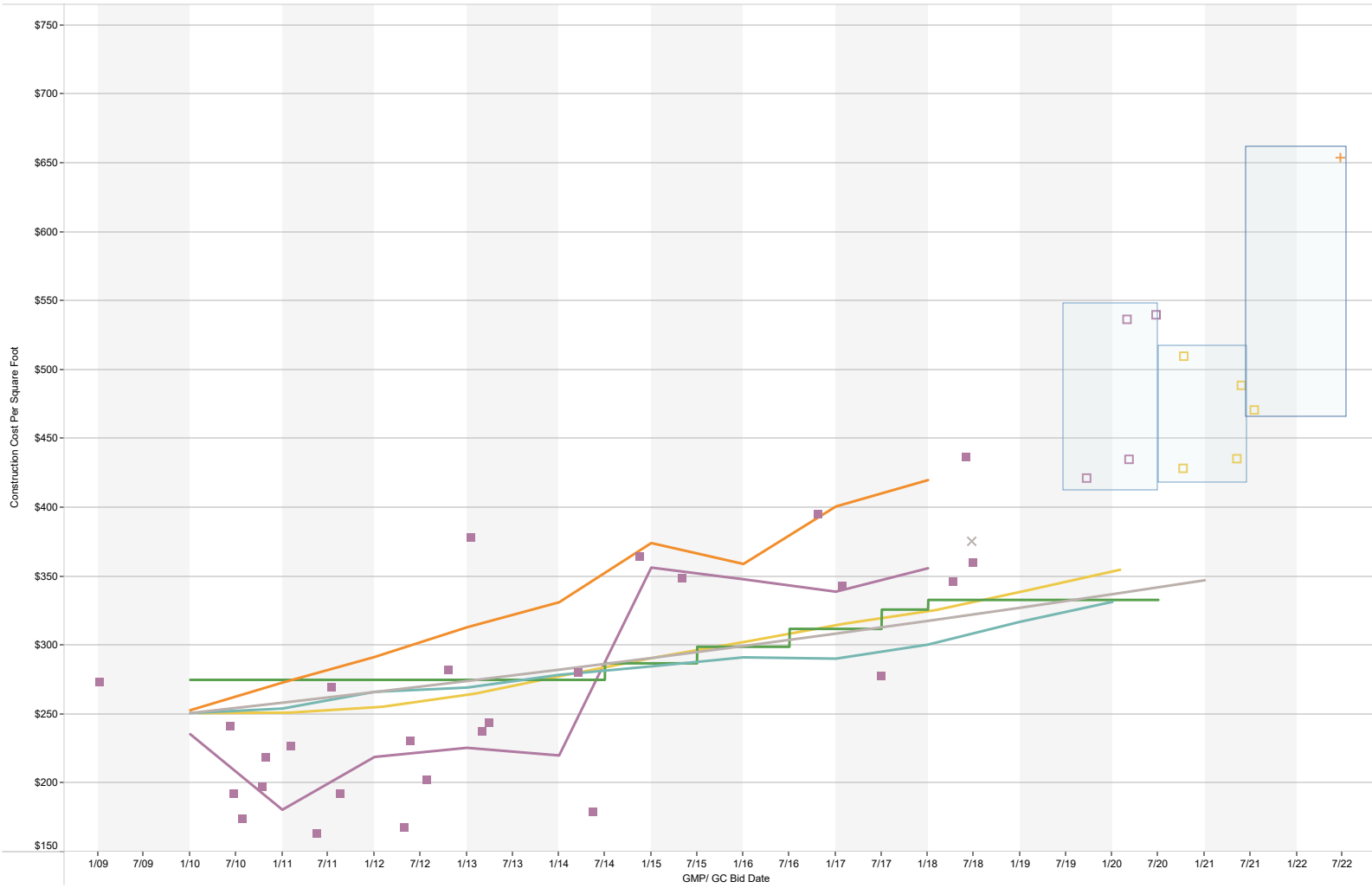

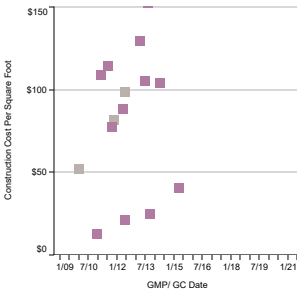
