

CAPITAL PIPELINE OVERVIEW

Status of Current Projects

A total of 303 projects that have received invitations from the Board of Directors ("Board") to collaborate with the Massachusetts School Building Authority ("MSBA") are currently in the MSBA's Eligibility Period and Capital Pipeline. The summary chart provides the number of projects in Eligibility Period and each phase of the Capital Pipeline. Compared to the prior Project Overview Report, the project total has increased by 24 projects, which reflects the removal of one project and the introduction of 25 Accelerated Repair Program ("ARP") projects invited at the December 16, 2020 Board of Directors meeting. Capital Planning Updates:

The following activities are scheduled for FY 2021:

- Model School Program Five responses were received on October 31, 2019. Site visits occurred at two
 of the schools prior to school closures. The selection committee reconvened in January 2021 to
 complete the evaluation of the two applicants for which site visits were conducted ahead of preparing a
 recommendation for the February 11, 2021 Board of Directors meeting. Due to ongoing public health
 issues, site visits for the remaining three applicants will resume when conditions allow for the visits to
 be conducted safely for all participants. In the interim, staff anticipate re-issuing the Model School
 Request for Services in February or March 2021 to allow for additional designer responses.
- The 2020 Statement of Interest ("SOI") submittal period opened on January 8, 2020 with ARP closing deadline on February 14, 2020. The closing deadline for Core Program SOIs was extended from April 8, 2020 to May 6, 2020.
 - The MSBA received 90 ARP SOIs for consideration. At the December 16, 2020 Board meeting, the Board of Directors approved the invitations for 18 districts representing 25 schools into the ARP.
 - Due to ongoing public health issues, the MSBA's due diligence for the Core Program, which includes senior study visits to select schools, has been delayed. Unlike prior years in which project invitations were approved at the December Board meeting, staff are continuing with the due diligence process and anticipate recommendations into Eligibility Period at a spring or early summer Board of Directors meeting.
- Staff have concluded with the consultant on the review of MSBA enrollment methodologies and will present an overview of the observations at the February 11, 2021 Board of Directors meeting.

- For the ARP, the procurement for Owner's Project Manager services is anticipated to be advertised in February 2021 and the procurement for Designer services is anticipated to be advertised in March 2021. Selected consultants will be assigned projects invited into the ARP in 2021, 2022, and 2023.

2021 Progress Report

- * Statements of Interest 2020 and 2021
 - Due to the delays caused by COVID-19, staff are continuing to complete the due diligence for the 2020 Core Program Statements of Interest and anticipate recommendations into Eligibility Period at a spring or early summer 2021 Board of Directors meeting. Staff anticipate that the 2021 Statements of Interest filing period will open upon completion of the 2020 Core Program due diligence.
- * Eligibility Period Core Program
 - Nine of the 11 2019 SOIs are currently in the Eligibility Period for the Core Program. Two 2019 SOIs received invitations to Feasibility Study at the December 2020 Board meeting while an additional three SOIs are anticipating invitations at the February 2021 Board meeting.
- * Feasibility Study/Schematic Design Core Program
 - One district completed its Owner's Project Manager ("OPM") selection since the last report and two districts are tentatively scheduled to receive MSBA approval for selection of their OPM.
 - Two districts completed their Designer selections and three districts are in the process of procuring a Designer.
 - 11 districts are anticipating submittals for their Preferred Schematic Solutions between February 2021 and June 2021.
 - Eight districts are anticipating submittals for their Project Funding Agreements between February 2021 and June 2021.
- * Accelerated Repair Program
 - All 18 districts from the 2020 ARP invitations are currently completing their initial documents.
- * Construction Costs Core Program
 - In 2019, MSBA staff anticipated DBB bids or GMP executions for 22 projects. All 22 projects have received sub-bids and 21 have proceeded to DBB bids or GMP execution. The remaining project revised its GMP execution to 2021 and is actively executing its GMP.
 - In 2020, MSBA staff anticipated DBB bids or GMP executions for 13 projects. All 13 projects have received sub-bids and 12 have proceeded to DBB bids or GMP execution. The remaining project is actively executing its GMP.
 - In 2021, an additional 14 projects are scheduled to receive sub-bids. MSBA staff anticipates DBB bids or GMP executions for 13 of the 14 projects in 2021 with the remaining project to follow in spring 2022.
- * Substantial Completion Core Program
 - Eight projects are scheduled to reach substantial completion in 2020. The MSBA has received executed certificates for four of the eight projects and anticipates receipt of four additional certificates. Since the last report, one project has revised its Substantial Completion from 2020 to 2021.

STATEMENTS OF INTEREST (SOIs)

2020 SOI Process

The 2020 SOI submittal period opened on January 8, 2020. The deadline to file SOIs for consideration into the Accelerated Repair Program, which is primarily for the replacement of roofs, windows/doors, and/or boilers in an otherwise structurally sound facility was Friday, February 14, 2020. The MSBA received 90 ARP SOIs for consideration. The deadline to file SOIs for consideration into the Core Program, which is primarily for projects beyond the scope of ARP, including extensive repairs, renovations, additions/renovations, and new school construction, was Wednesday, May 6, 2020. The MSBA received 71 Core Program SOIs for consideration.

For qualifying ARP SOIs, staff completed site visits for roof and window/door projects in coordination with MassDOT's Aeronautics Drone Program and received photo documentation of existing boiler room equipment for boiler projects. Staff presented initial recommendations for invitation at the December 2, 2020 Facilities Assessment Subcommittee. At the December 16, 2020 Board meeting, the Board of Directors approved invitations for 18 districts representing 25 schools into the ARP.

Due to ongoing public health issues, the MSBA's due diligence for the Core Program, which includes senior study visits to select schools, has been delayed. Unlike prior years in which project invitations were approved at the December Board meeting, staff are continuing with the due diligence process and anticipate recommendations into Eligibility Period at a spring or early summer Board of Directors meeting.

There are nine districts in the Eligibility Period and six of those districts have secured their local funding.

An agreed-upon enrollment is a key pre-requisite for the MSBA to commence a Feasibility Study with a district. To begin the enrollment projection process, a district must file enrollment information utilizing the MSBA's online enrollment projection tool.

CONSULTANT SELECTION

Owner's Project Manager Selection

After the district has completed all Eligibility Period requirements and has received a Board Invitation to Feasibility Study, the district procures an OPM. Since the last report, Haverhill has completed its OPM selection (shaded in the table below). Currently, there are two districts in the Capital Pipeline in the process of procuring an OPM.

Designer Selection

After a district has selected and executed a contract with an OPM, the district selects a Designer by utilizing either a local designer selection process for projects under \$5 million or the MSBA's Designer Selection Panel ("DSP") for projects over \$5 million. Since the last report, Brookline and Webster have completed their Designer selections (shaded in the table below). There are currently three districts in the Capital Pipeline that are in the process of procuring a Designer.

FEASIBILITY STUDY

Once a district has procured an OPM and a Designer, the district and the district's consultants must complete two Feasibility Study submittals, the Preliminary Design Program, and the Preferred Schematic Report, prior to Board consideration to proceed into Schematic Design. Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that 12 districts will appear before the Board for their Preferred Schematic Design authorizations at the February 2021, April 2021, and June 2021 Board meetings.

To date, the MSBA has executed 535 commissioning consultant contracts, totaling \$40.2 million in commissioning fees, for 731 projects at 627 schools, many of whom have been invited to the Capital Pipeline multiple times. Construction budgets for projects being commissioned total \$12.5 billion. To date, 387 work orders have been completed.

DESIGN DEVELOPMENT

After a district has secured local funding and has entered into a Project Funding Agreement ("PFA") with the MSBA, the district enters into the Design Development Phase. Currently, there are 26 projects in the Design Development Phase with a total estimated construction cost of approximately \$1.49 billion. Of those 26 projects, 14 are ARP Projects and 12 are Core Program Projects. The 12 Core Program Projects in Design Development have a total estimated construction cost of approximately \$1.46 billion and are listed below.


SUMMARY OF BID DATA



The graph below plots Schematic Design Construction Estimates and Construction Bid Results for new construction projects from July 2018 to present. The projects are presented based on their dates of DBB bids or GMP executions. The graph includes nine new construction projects in FY 2019, eleven new construction projects in FY 2020, and nine new construction project in FY 2021. The Orange Line is a trend line for Bid Costs and the Blue Line is a trend line for Schematic Design Construction Estimates. *Arlington, Bridgewater-Raynham, Marblehead, Pentucket, and Tewksbury have been added since the last report prepared for the December 16, 2020 Board meeting. Bid results for Arlington, Bridgewater-Raynham, Marblehead, and Tewksbury were within their estimated construction budgets. Pentucket's Guaranteed Maximum Price exceeds the project's estimated construction budget but remains within the Total Project Budget.*

There were no addition/renovation projects in FY 2019. The Purple Line is a trend line for Bid Costs and the Yellow Line is a trend line for Schematic Design Estimates. *There have been no new projects added since the last Project Overview Report prepared for the December 16, 2020 Board meeting.*

CONSTRUCTION

When a district with a Design-Bid-Build Construction project issues a Notice to Proceed, or when a Construction Manager At-Risk project has received bids for the concrete foundation package, the project is advanced to the Construction Phase. Currently, there are 71 projects in the Construction Phase with a total estimated construction cost of \$3.35 billion. Of those 71 projects, 38 are ARP Projects and 33 are Core Program Projects; however, this does not include the 33 projects that have reached substantial completion and are currently in the Building Complete Phase. The 33 Core Program Projects have a total estimated construction cost of \$3.29 billion and are listed below.

Amendment to the Project Funding Agreement (PFA)

Upon receipt of construction bids or the execution of a GMP, a district submits the Contractor's Schedule of Values to the MSBA. MSBA staff will collaborate with the district to reconcile the construction costs from the schedule of values against the estimated construction budget. Afterwards, an amendment to the PFA is executed to reflect the bids received for those projects. The chart, shown below, is the number of amendments to PFAs listed by fiscal year.

<u>CLOSEOUT</u>

After the district's contractor finishes all project work including, demolishing the old building, completing site work, and finalizing commissioning, the project proceeds to the Closeout Phase. Once all the project costs have been paid by the District, the District submits its Final Request for Payment Reimbursement via the MSBA's Pro-Pay system. After the District submits all the items identified on the MSBA's Index of Final Closeout, including the Final Request for Payment Reimbursement, the MSBA initiates the Draft Audit Report and sends it to the District for its consideration. The MSBA performs the final audit to determine final total grant amounts. Final payment to the District requires the MSBA Board's approval of the final Total Facilities Grant for the project.

Currently, there are 86 projects in the Closeout Phase including 61 ARP Projects and 25 Core Program Projects. The chart, shown below, lists the Core Program Projects by year of achieved Substantial Completion:

ACCELERATED REPAIR PROGRAM



The photos above depict the before and after of the windows at Stoughton's Richard L. Wilkins Elementary School, formerly known as the West Elementary School, serving 284 students. The project replaced the windows/doors, thus extending the useful life of the 70-year-old building. The project reached Substantial Completion in May 2019 and is scheduled to receive Final Audit Approval at the February 11, 2021 Board meeting.

Currently, there are **176** ARP projects in the MSBA's Eligibility Period and Capital Pipeline. *The 176 projects include 25 projects approved for invitation at the December 16, 2020 Board of Directors meeting and 15 projects approved for Final Audit in FY 2021. Prior to FY 2021, 172 projects received Final Audit approval. The combined 348 projects are located in 132 districts, many of whom have been invited to the ARP multiple times. All the new information that has been updated since the last report is <i>italicized and bolded*.











Accelerated Repair Projects – Schedule Extension Update

The MSBA has granted districts conditional extensions to their PFAs pending compliance with the following stipulations:

- The district must submit a detailed, revised, construction timeline that explains how the work will be completed at each school; and
- Any costs that are related to a district requesting an extension to the construction schedule will be the sole responsibility of the district, and those costs are categorically ineligible for reimbursement by the MSBA.

Schedule delays for these districts can be attributed to local funding issues, lead time for windows, and construction delays on site. In no event have the extended schedules resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board.

Six of the 34 2017 ARP Projects revised their construction schedules to reflect substantial completion in 2021 or beyond. Staff has reported previously on the shaded projects listed below, which remain in Construction or Design Development.




