

CAPITAL PIPELINE OVERVIEW

Status of Current Projects

A total of 321 projects that have received invitations from the Board of Directors ("Board") to collaborate with the Massachusetts School Building Authority ("MSBA") are currently in the MSBA's Eligibility Period and Capital Pipeline. The summary chart provides the number of projects in Eligibility Period and each phase of the Capital Pipeline. Compared to the prior Project Overview Report, the project total has increased by 16 projects to reflect 17 projects invited to the Core Program and one project removed from the Accelerated Repair Program at the March 2, 2022 Board of Directors meeting. Capital Planning Updates:

The following activities are scheduled for FY 2022:

- Request for Responses was issued for Project Management Services. The objective of the procurement is to assist the MSBA in construction administration, final closeout, and archiving of Capital Pipeline projects. One response was received. Staff provided an update to Facilities Assessment Subcommittee on February 2, 2022 and received approval to execute a Master Service Agreement at the March 2, 2022 Board of Directors meeting.

2022 Progress Report

- * Statements of Interest 2022
 - The 2022 SOI submittal period opened on January 28, 2022. The deadline to file for consideration in the Accelerated Repair Program was March 25, 2022, while the deadline to file for consideration in the Core Program is April 29, 2022.
 - The MSBA received 67 ARP SOIs for consideration.

- * Eligibility Period Core Program
 - Seven of the 15 2020 SOIs are currently in the Eligibility Period for the Core Program. Eight 2020 SOIs received invitations to Feasibility Study through the March 2, 2022 Board of Directors meeting while an additional six SOIs are anticipating invitations at the April 27, 2022 Board of Directors meeting.
 - The 17 2021 SOIs are currently in the Eligibility Period following their invitations at the March 2, 2022 Board of Directors meeting.
- * Feasibility Study/Schematic Design Core Program
 - One district has completed its Owner's Project Manager ("OPM") selection since the last report and eight districts are tentatively scheduled to receive MSBA approval for selection of their OPM.
 - No district completed Designer selection since the last report while four districts are in the process of procuring a Designer.
 - Six districts are anticipating submittals for their Preferred Schematic Solutions between April 2022 and August 2022.
 - Four districts are anticipating submittals for their Project Scope and Budget Agreement authorizations between April 2022 and August 2022.
- * Accelerated Repair Program
 - All 18 districts from the 2020 ARP invitations have received consultant assignments. 16 districts received project funding agreement approval through the March 2, 2022 Board of Directors meeting while one district was removed from the Capital Pipeline. The remaining district will be removed from the Capital Pipeline at the April 27, 2022 Board of Directors meeting.
 - All 16 districts from the 2021 ARP invitations have received consultant assignments.
- * Construction Costs Core Program
 - In 2022, 16 projects are scheduled to receive sub-bids. MSBA staff anticipates DBB bids or GMP executions for 12 of the 16 projects in 2022.
- * Substantial Completion Core Program
 - 19 projects were scheduled to reach substantial completion in 2021. The MSBA has received executed certificates for 18 of the 19 projects and anticipates receipt of the final certificate.
 - 15 projects are scheduled to reach substantial completion in 2022.
- * Post Occupancy Evaluations
 - \circ Staff anticipates completing at least nine and potentially up to 12 POE visits by June 2022.

STATEMENTS OF INTEREST (SOIs)

2022 SOI Process

The 2022 SOI submittal period opened on January 28, 2022. The deadline to file SOIs for consideration into the Accelerated Repair Program ("ARP"), which is primarily for the replacement of roofs, windows/doors, and/or boilers in an otherwise structurally sound facility was March 25, 2022. The MSBA received 67 ARP SOIs for consideration from 29 districts. The deadline to file SOIs for consideration into the Core Program, which is primarily for projects beyond the scope of ARP, including extensive repairs, renovations, additions/renovations, and new school construction, is April 29, 2022.

CORE PROGRAM

ELIGIBILITY PERIOD

There are 24 districts in the Eligibility Period and seven of those districts have secured their local funding.

An agreed-upon enrollment is a key pre-requisite for the MSBA to commence a Feasibility Study with a district. To begin the enrollment projection process, a district must file enrollment information utilizing the MSBA's online enrollment projection tool.

Designer Selection

After a district has selected and executed a contract with an OPM, the district selects a Designer by utilizing either a local designer selection process for projects under \$5 million or the MSBA's Designer Selection Panel ("DSP") for projects over \$5 million. Since the last report, no districts have completed their Designer selection. There are currently four districts in the Capital Pipeline that are in the process of procuring a Designer.

FEASIBILITY STUDY

Once a district has procured an OPM and a Designer, the district and the district's consultants must complete two Feasibility Study submittals, the Preliminary Design Program, and the Preferred Schematic Report, prior to Board consideration to proceed into Schematic Design. Based on the most recent data and schedules provided to the MSBA by districts, the MSBA anticipates that six districts will appear before the Board for their Preferred Schematic Design authorizations at the April 2022, June 2022, and August 2022 Board meetings.

To date, the MSBA has executed 570 commissioning consultant contracts, totaling \$43.7 million in commissioning fees, for 771 projects at 655 schools, many of whom have been invited to the Capital Pipeline multiple times. Construction budgets for projects being commissioned total \$14.1 billion. To date, 426 work orders have been completed.

DESIGN DEVELOPMENT

After a district has secured local funding and has entered into a Project Funding Agreement ("PFA") with the MSBA, the district enters the Design Development Phase. Currently, there are 35 projects in the Design Development Phase with a total estimated construction cost of approximately \$1.90 billion. Of those 35 projects, 16 are ARP Projects and 19 are Core Program Projects. The 19 Core Program Projects in Design Development have a total estimated construction cost of approximately \$1.86 billion and are listed below.





The graph includes six new construction projects in FY 2019, eleven new construction projects in FY 2020, 17 new construction projects in FY 2021, and five new construction projects in FY 2022. The Orange Line is a trend line for Bid Costs and the Blue Line is a trend line for Schematic Design Construction Estimates. *Gloucester and Ashland have been added since the last report prepared for the March 2, 2022 Board of Directors meeting. Bid results for Gloucester and Ashland were above the estimated construction budget.*

CONSTRUCTION

When a district with a Design-Bid-Build Construction project issues a Notice to Proceed, or when a Construction Manager At-Risk project has received bids for the concrete foundation package, the project is advanced to the Construction Phase. Currently, there are 39 projects in the Construction Phase with a total estimated construction cost of \$3.15 billion. Of those 39 projects, 12 are ARP Projects and 27 are Core Program Projects; however, this does not include the 41 projects that have reached substantial completion and are currently in the Building Complete Phase. The 27 Core Program Projects have a total estimated construction cost of \$3.13 billion and are listed below.

Amendment to the Project Funding Agreement (PFA)

Upon receipt of construction bids or the execution of a GMP, a district submits the Contractor's Schedule of Values to the MSBA. MSBA staff will collaborate with the district to reconcile the construction costs from the schedule of values against the estimated construction budget. Afterwards, an amendment to the PFA is executed to reflect the bids received for those projects. The chart, shown below, is the number of amendments to PFAs listed by fiscal year.

<u>CLOSEOUT</u>

After the district's contractor finishes all project work including, demolishing the old building, completing site work, and finalizing commissioning, the project proceeds to the Closeout Phase. Once all the project costs have been paid by the District, the District submits its Final Request for Payment Reimbursement via the MSBA's Pro-Pay system. After the District submits all the items identified on the MSBA's Index of Final Closeout, including the Final Request for Payment Reimbursement, the MSBA initiates the Draft Audit Report and sends it to the District for its consideration. The MSBA performs the final audit to determine final total grant amounts. Final payment to the District requires the MSBA Board's approval of the final Total Facilities Grant for the project.

Currently, there are 89 projects in the Closeout Phase including 67 ARP Projects and 22 Core Program Projects. The chart, shown below, lists the Core Program Projects by year of achieved Substantial Completion:

POST OCCUPANCY EVALUATION

Approximately three years after an MSBA-funded school building reaches substantial completion, the MSBA will coordinate with districts to distribute post occupancy surveys and pre-visit questionnaires and to schedule building visits with district representatives to complete a Post Occupancy Evaluation ("POE"). The MSBA's POE process was developed in part to assist the MSBA in understanding that MSBA-funded school building projects are operating as intended and performing as designed. In addition, the collection of technical data accompanied by school district and occupant feedback enables the MSBA, school districts, and the consultant community to apply lessons learned to future school building projects as well as to the ongoing maintenance and operations of MSBA-funded school buildings.

Staff anticipate completing at least nine and potentially up to 12 POE visits in FY 2022. The nine are listed in the table below. Staff will continue to provide updates for these projects.


The photos above depict the roof replacement at Danvers' Highlands Elementary School, serving 367 students. The project replaced the roof, thus extending the useful life of the 66-year-old building. The project reached Substantial Completion in September 2019 and is scheduled to receive Final Audit Approval at the April 27, 2022 Board of Directors meeting.

Currently, there are **174** ARP projects in the MSBA's Eligibility Period and Capital Pipeline. The **174** projects include **30** projects approved for Final Audit in FY 2022. Prior to FY 2022, 198 projects received Final Audit approval. The combined **372** projects are located in 134 districts, many of whom have been invited to the ARP multiple times. All the new information that has been updated since the last report is *italicized and bolded*.















Accelerated Repair Projects – Schedule Extension Update

The MSBA has granted districts conditional extensions to their PFAs pending compliance with the following stipulations:

- The district must submit a detailed, revised, construction timeline that explains how the work will be completed at each school; and
- Any costs that are related to a district requesting an extension to the construction schedule will be the sole responsibility of the district, and those costs are categorically ineligible for reimbursement by the MSBA.

Schedule delays for these districts can be attributed to local funding issues, lead time for materials, and construction delays on site. In no event have the extended schedules resulted in an increase to the Estimated Maximum Total Facilities Grant, as authorized by the Board.

Two of the 30 2018 ARP Projects revised their construction schedules to reflect substantial completion in 2021 or beyond. Staff has reported previously on the shaded project listed below, which remains in Construction.




