Recommendation

That the Executive Director be authorized to enter into a Project Scope and Budget Agreement and a Project Funding Agreement with the Town of Wilmington (the "District") to consolidate the student population of the existing Wildwood Elementary School, Woburn Street Elementary School, and North Intermediate Elementary School and construct a new facility serving Kindergarten through grade 5, plus Pre-kindergarten, on the site of the existing North Intermediate School.

If the District does not meet the requirements of the Green Schools Program, the District will not qualify for some or all of these incentive points, and the MSBA will adjust the reimbursement rate accordingly.

Discussion

MSBA staff reviewed the documents provided by the District and met with the District and its consultants to discuss scope and budget. The District has provided a Total Project Budget of \$173,265,626, which includes an estimated construction cost of \$137,743,666 (\$835/sq. ft.). The Estimated Basis of Total Facilities Grant would be \$113,843,327 which excludes the following: legal fees; OPM and Designer fees associated with excluded scope associated with the gymnasium; OPM and Designer fees beyond MSBA funding limits; costs associated with asbestos-containing floor material and ceiling tile abatement; construction costs for building and site work beyond MSBA funding limits, which includes scope associated with ineligible building area; costs associated with mailing and moving; costs exceeding the \$1,200 per student allowance for furniture, fixtures, and equipment; and costs exceeding the \$1,200 per student allowance for technology. The Total Project Budget also excludes costs associated with the commissioning of ineligible building area as well as owner's and construction contingency costs beyond MSBA funding limits.

Additionally, the proposed demolition of the North Intermediate School will result in the MSBA recovering a portion of state funds previously paid to the District for the Accelerated Repair Windows/Doors replacement project at the existing North Intermediate School completed in September 2014. The MSBA has calculated this recovery of funds to be \$209,597 and this amount has been deducted from the Estimated Maximum Total Facilities Grant.

MSBA staff recommends an Estimated Maximum Total Facilities Grant of \$62,134,793; however, the District may be eligible for up to an additional \$1,131,840 in grant funds, subject to the MSBA's review and audit of the District's owner's and construction contingency expenditures. Accordingly, staff recommends a Maximum Total Facilities Grant of \$63,266,633 for the Project Scope and Budget Agreement and Project Funding Agreement to consolidate the student population of the existing Wildwood Elementary School, Woburn Street Elementary School, and North Intermediate Elementary School and construct a new facility serving Kindergarten through grade 5, plus Pre-kindergarten, on the site of the existing North Intermediate School.

³Includes maximum possible Owner's and Construction Contingency grant funds, the final amount of which, if any, shall be determined by the MSBA in its sole discretion. ⁴Maximum Total Facilities Grant will be allocated in part to the current Grant Cap, and in part to future available Grant Cap space.
