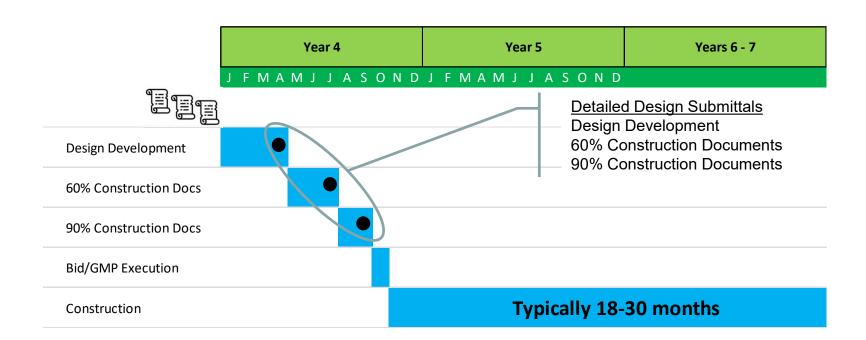


### MSBA Design & Construction Process



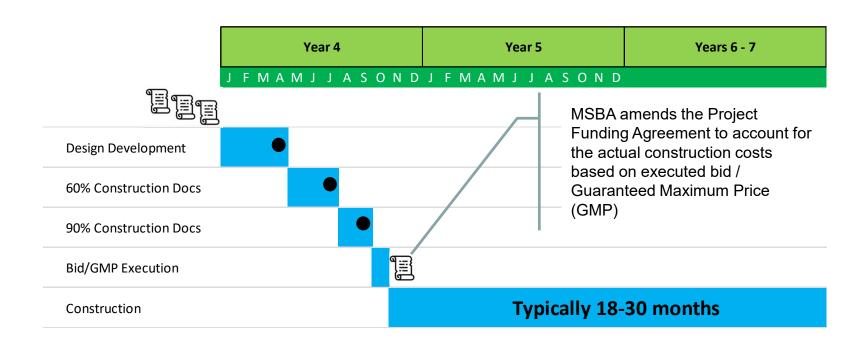

- MSBA is in the early phases of implementing a post occupancy review program

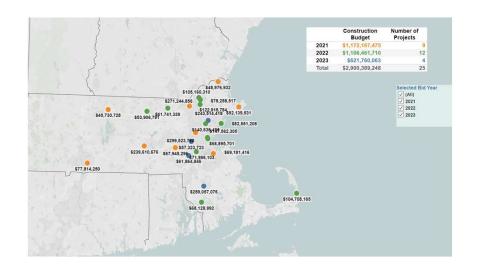

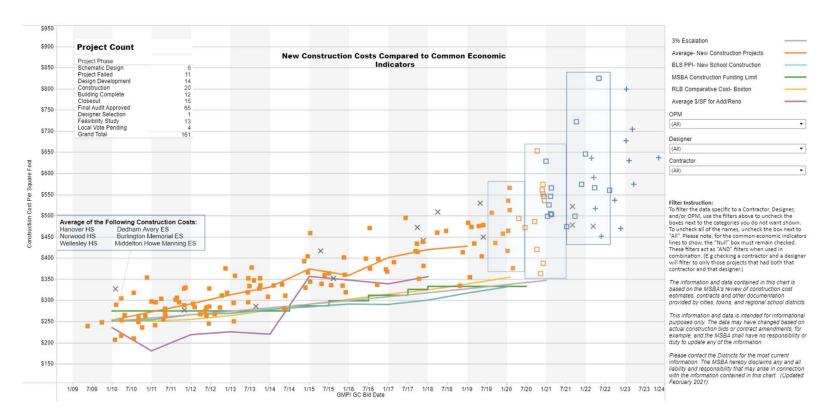
